A regular meeting of the Urbana-Champaign Senate was called to order at 3:15 p.m. at the Levis Faculty Center with Chancellor Richard Herman presiding.

Senate Executive Committee Report

Senator Nicholas Burbules (EDUC), Chair of the Senate Executive Committee (SEC), provided the following report.

At the door today, please pick up SC.09.07, Senate Resolution on Faculty Commitments Outside UIUC Campus.

In his opening remarks, SEC Chair Nicholas Burbules reported that he has been asked by President Joseph White to chair a task force charged with drafting an alternative model for the Global Campus initiative. President White plans to take three proposals to the Trustees at their May meeting: keep Global Campus as it is, shut it down, or change it into something else.

This alternative proposal will be brought back to Senates Conference and, through them, back to the campuses for review and comment.

Chancellor's Remarks

Chancellor Herman reported on a number of issues concerning the fiscal climate and University budget, including the need for scholarships to recruit quality students who might otherwise attend community college; the prospect of a major stimulus package by the State to benefit education and research; exceptional fund-raising efforts by the Center for Latin American and Caribbean Studies to establish a Center for Brazilian Studies; and the acquisition of research support dollars for the multi-institutional degree program at the University of Singapore.

Questions/Discussion

Senator Ilia Kapovich (LAS) asked who actually will distribute the economic stimulus funds the University is expecting from the state. The Chancellor replied that the governor's office will be involved.

Committee of the Whole

The Senate approved a motion to convene as a Committee of the Whole to discuss ProQuest and Dissertation Deposits. Debasish Dutta, Dean of the Graduate College, made introductory remarks and background on this matter, and then turned the podium over to Rebecca Bryant, Assistant Dean of the Graduate College.

Dr. Bryant presented a brief history of the University's relationship with ProQuest and UMI (University Microfilms, Inc.). Because ProQuest is publishing documents online, there are potential questions for graduate students about whether previously published sections of the dissertation can be reused without permission in the ProQuest published version; and questions about whether subsequent publication of all or part of the dissertation, after the ProQuest version is published, might be resisted by publishers who consider the ProQuest version a form of prior publication of the same material. Students should be aware of their copyright privileges and how to protect them. For more information, see: http://www.grad.illinois.edu/thesis/
