Title of the minor: Minor in Adult Development (Human Development and Family Studies, ACES)

Brief description of the program of study:

The adult development minor combines theoretical and practical approaches to understanding issues faced by adults as individuals, partners, family members, learners, caregivers, citizens, and clients of social agencies. Course work examines adults from age 25 to 90+ in the contexts of evolving family roles, health issues, and social service needs. The minor requires a minimum of 18 hours: nine hours of courses on adult development and aging, three or four hours of courses on adult roles in the family, and six hours of courses examining particular adult capabilities and challenges. Students may meet part of the last requirement via a community-based practicum or research project related to adult development.

Justification:

We are proposing revisions the minor in Adult Development. Now that we have had the minor for a few years, we noticed that students had difficulty completing the foundation courses because they were only taught once a year (if that often). We would like to remedy this issue by adding a foundational course, HDFS 120 Intro to Family Studies (taught every semester), and making several of the other courses a part of the Adult choices/challenges elective options. We are also adding some additional electives to the Adult choices/challenges to address content important in adult development

Change in demand for any single non-HDFS course is expected to be negligible, and non-HDFS courses are only included where a choice among several courses is available to meet a requirement. Approvals from departments controlling non-HDFS courses are attached.

d. Impact on library, computer use, laboratory use, equipment, etc.

No change anticipated; minor relies on existing courses.

Prerequisites for the minor: None

Current enrollment in the minor: Currently, there are 8 students in the minor. We don't expect these changes to alter the demand for the Adult Development Minor.

Admission to the minor: Admission will be managed by the HDFS advising coordinator. Students seeking admission will meet with the HDFS advisor and complete the necessary paperwork. Should admission limits become necessary, an application and review process will be initiated similar to that now in use for intercollege transfers.

Minor advisor: The minor advisor will consult with students seeking admission to the minor, recommend students for admission, advise admitted students with respect to academic progress and course selection, and handle petitions for modifications to the published minor requirements.

Certification of successful completion: The student's college of enrollment will add the minor to the student's Banner record and certify completion when all requirements for the minor have been met. When a student needs to complete a minor requirement with a course not specifically indicated in the program requirements – the minor advisor will approve a Minor Modification, and forward it to the student's college so the replacement course can be counted as meeting the requirement.

Course work examines adults from age 25 to 90+ in the contexts of evolving family roles, health issues, and social service needs. Students anticipating careers in social or health-related services will find an understanding of adult development and its attendant issues a valuable complement to other professional skills.

The minor requires a minimum of 18 hours. Students may count three hours earned in a community-based practicum or research project related to adult development toward the minor.
