PROPOSAL TITLE: Transfer the Regional Economics Applications Laboratory (REAL) from the Institute of Government and Public Affairs to the Department of Agricultural and Consumer Economics in the College of Agricultural, Consumer and Environmental Sciences.

BRIEF DESCRIPTION: We propose to move REAL from Institute of Government and Public Affairs (IGPA) to the Department of Agricultural and Consumer Economics (ACE) in the College of Agricultural, Consumer and Environmental Sciences (ACES). REAL is a grant-funded laboratory that was created in 1989 as a cooperative venture between the Federal Reserve Bank of Chicago and the University of Illinois focusing on the development and use of analytical models for urban and regional economic development. The official transfer will integrate a public service component into the range of economic impact and analytical modeling activities within ACE and will allow IGPA to consolidate and focus its efforts on its core mission—public policy research and leadership training in service of the State of Illinois.

The proposed transfer was approved in concept by ACE Department Head John (Sean) Fox, ACES Dean Kimberlee Kidwell, Interim IGPA Director Jon Davis, and EVPAA Barbara J. Wilson on Oct. 31, 2018.

JUSTIFICATION: REAL was formed with the intent of providing high quality economic modeling capability at modest cost to individuals, public and private corporations, and federal, state, and local government agencies interested in understanding past economic trends and desiring projections on future employment and production levels. The Laboratory is staffed by professionals drawn from personnel of the University of Illinois at Urbana-Champaign and

several graduate research assistants from several departments including IGPA, Agricultural and Consumer Economics, Economics, and Urban and Regional Planning. While REAL's primary focus has been on the economies of the Midwest, REAL has collaborated in the development of econometric models for several regions on the east coast, for states in Brazil and for the Jakarta

Metropolitan region. Pilip Israilevich (FED Chicago) and Geoffiey J.D. Hewings (UIUC) were the founders of this not-for-profit Laboratory. The joint venture with the Federal Reserve Bank of Chicago lasted until 2001.

The transfer of REAL to ACES was originally discussed in 2017 after the retirement of Hewings and appointment of a new director, Sandy Dall'erba, whose academic appointment is in the

Department of ACE. A series of discussions ensued among IGPA and ACES to assess the benefits and costs of the transfer, and the two units agreed that the move would constitute a good programmatic fit and a net positive for their units and the University. Most importantly, the transfer will strengthen both IGPA and ACES. REAL will continue the work on its grants, intergovernmental agency agreements and contracts throughout the transfer process, minimizing disruption to all projects as much as possible.

The justification for the transfer of personnel is that the current REAL employees are essential to completing the goals and mission of REAL. IGPA will assume the financial liability for paid benefits of vacation and/or sick leave hours accrued through the time of transfer for these personnel. The REAL staff will maintain their lines of reporting structure.
