We have been offering the Schools specialization requirements to allow students to gain their Illinois Professional Educator License (PEL) with Endorsement in School Social work for the past several years. However, up to this point these students return to complete this requirement under a "non-degree" code. Due to them being categorized as a "non-degree" student they are not eligible for FAFSA to assist in covering the post of their tuition. With the expansion of the iMSW program in Chicago our inquiries for this program have doubled in size the past two years but once they apply and find out they aren't eligible to apply for student loans many students aren't able to seek this endorsement. Students completing this program are entitled by the Council on Teachers Education with a School Social Worker License. By creating an Advanced Certificate for Post MSW Students at the Graduate College level this will allow a program code to be designed for this advanced certificate and students would then be eligible for FAFSA to help cover the cost of the Schools Specialization program.

The State of Illinois is in great need of School Social Workers and students must possess the School Social Worker Endorsement to be eligible to be a School Social Worker in Illinois.

Student learning outcomes are assessed with the nine social work competencies and relate practice behaviors that are required by the Council of Social Work Education (CSWE). Assessment activities are multi-faceted. First, an online assessment survey that includes multiple-choice questions is conducted before students enter their field practicum, after completing their course work. Second, field instructors assess students learning at the end of their field placement. In addition, we also conduct an annual post-graduation survey to obtain information on student program experiences. Aggregated assessment outcomes from these activities are shared with the School's program and curriculum committees as well as with faculty members and are used to identify areas of program strengths and weakness. Decisions for program improvement are made accordingly
