### I. CALL TO ORDER

A regular meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:10 pm with Senate Executive Committee (SEC) Chair Rob Kar (LAW) presiding and Professor Emeritus H. George Friedman, Jr. serving as Parliamentarian. Chair Kar then conducted a test vote of the Poll Everywhere system.

### II. APPROVAL OF MINUTES

09/20/21-01 Without objection, the minutes of the April 26, 2021 and May 3, 2021 meetings were approved as distributed by unanimous consent.

### III. PUBLIC COMMENT

Faculty senator Ralph Mathisen (LAS) spoke about concerns regarding COVID and inperson teaching.

## V. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Chair Kar announced that the Senate would continue to meet via Zoom webinar if Governor Pritzker continues to issue disaster proclamations and it is determined not to be feasible to meet in person. It is also consistent with general education policy that classes over 200 are held remotely.

Kar thanked everyone for the strong vaccination rates and noted that Provost Cangellaris will discuss this topic further.

Chair Kar reported that a graduate student senator vacancy remains on the Senate Committee on Committees (CC). If a graduate student senator is interested in serving on CC, please contact the Office of the Senate. Also, the student members of the SEC have yet to be elected. Please watch your email this week for an email from Clerk of the Senate Roether for additional information on the nominating procedures.

#### VI. CHANCELLOR'S REMARKS

Vice Chancellor for Academic Affairs and Provost Andreas Cangellaris gave remarks on behalf of Chancellor Robert Jones. Cangellaris thanked everyone for their participation in shared governance. Shared governance participation has been instrumental in the safe and successful navigation of the COVID pandemic.

Cangellaris stated that the 10-day numbers, which is when the official fall enrollment is based, show an all-time high enrollment for first year student, for graduate students, and the overall student body. These record numbers are not sustainable under current University infrastructure. Moving forward we must find creative solutions to the demand for higher education.

There is a downward trend in the number of positive COVID tests. The University continues to work closely with the Champaign-Urbana Public Health District (CUPHD) on a multilayered mitigation strategy. High vaccination rates and high compliance with testing protocols has contributed to the downward trend in COVID cases. Additional information will be provided later in the meeting from SHIELD experts.

As of this morning, the following vaccination rates were reported: 90% undergraduate students, 93% graduate students, 87% faculty, 90% academic professional, and 71% civil service. This is about 30% higher than the county average and about 36% higher than the national average. CUPHD is the local legal authority for contact tracing.

## VII. QUESTIONS

Faculty senator Benson (LIBR) inquired about relocating the reporting line of Disability Resources and Educational Services (DRES) from the College of Applied Health Sciences (AHS) and moving it under the Vice Chancellor for Diversity, Equity, and Inclusion (VCDEI). Cangellaris noted that DRES is uniquely positioned to have a significant educational and research component, the thinking is to restructure the broader DRES umbrella in such a way that all the academic and research activities stay with the units. This means not only AHS, but also all the other contributing units. This will also assist with meeting the compliance requirements especially related to ADA (American Disabilities Act) requirements and provide a more centralized oversight structure.

Faculty senator Rosenstock (LAS) asked about the University's cooperation with CUPHD. At the September SEC meeting, Cangellaris noted that CUPHD works in collaboration with the Office of Student Affairs and McKinley Health Center on contact tracing. Rosenstock asked if McKinley would be able to provide data such as classroom rosters and how many of students in each classroom are vaccinated. Dr. Awais Vaid previously provided a response to this question in writing. Vaid reiterated that CUPHD is following the guidance that has been put forward by the CDC (Centers for Disease Control and Prevention) and adopted by the Illinois Department of Public Health (ILDPH).

## VIII. REVIEW OF PARLIAMENTARY PROCEDURE

H. George Friedman, Jr., Parliamentarian, reviewed basic parliamentary procedure and directed senators to the quick guide that was in the meeting packet. ### XIII. COMMITTEE OF THE WHOLE DISCUSSION

09/20/21-41 Vice Chair Dallesasse made a motion to move into a committee of the whole to consider the authority to decide and/or change teaching modalities during COVID. The motion was seconded and approved without objections by unanimous consent.

Faculty senator Rosenstock (LAS) expressed concern about contact tracing. Concern was also expressed for faculty that have small children that are unable to be vaccinated and has a student that tests positive for COVID. Rosenstock felt that other faculty are nervous about positive cases in their classrooms.

Smith (SHEILD team member) responded to a question noting that the idea of random testing has been discussed and has not been found effective in finding breakthrough cases. Rather, students that are vaccinated and living in buildings that have a large number of cases are required to test. This is a much more effective method of determining breakthrough cases.

Faculty senator and SHIELD team member Elbanna (ENGR) shared slides about COVID progression on campus. Data from Fall 2021 and Fall 2020 were compared, including the emergence of the Delta variant.

- 09/20/21-43 Through the online voting system Poll Everywhere, the motion to rise and report failed with 40 in favor, 69 opposed, and 7 abstentions. Discussion continued.

09/20/21-43 A motion was made and seconded to rise and report. Without objection, the motion to rise and report was approved by unanimous consent.

SP.19.15 Proposed Revisions to the *Statutes*, Article IV, Section 1 – The Department, Section 2 – Department Organized with a Chair, Section 3 – Department Organized with a Head, and Section 4 – Change of Departmental Administrative Organization

### **BACKGROUND**

Currently, *Statutes* Article IV (Departments), Sections 1 (The Department), 2 (Department Organized with a Chair), 3 (Department Organized with a Head), and 4 (Change of Departmental Administrative Organization), especially Sections 2 and 3, are unclear, incoherent, not parallel, and generally confusing. Proposed revisions put current items, all of which have been retained or revised, in a more logical, consistent, and coherent order and strengthens shared governance in academic and research matters that directly affect faculty.

The department is the primary unit of education and administration (*Statutes*, Article IV, Section 1a). A proposed change in Section 1a would provide an additional opportunity for faculty participation. Specifically, any academic appointment in a department would be made with the prior advice of the faculty.

A department may be organized administratively either with a chair or with a head (Section 1c). Current *Statutes* provide for the annual appointment of a chair (Section 2a) and for the appointment of a head (Section 3a) without specified term, but do not provide a consultative process for the initial appointment of a chair or head.

Proposed changes to Sections 2 and 3, therefore, would provide an opportunity to strengthen shared governance and promote diverse representation. Specifically, proposed changes in the initial appointment of a chair (Section 2) or head (Section 3) would require the dean to seek advice of a committee selected by the faculty of the department. These changes align with the current procedure for the initial appointment of a chancellor/vice president, in which a committee is selected by the senate to advise the president (*Statutes*, Article I, Section 5). Similar to that procedure, and to the recently senate-approved proposal regarding the initial appointments of a dean, director, and campus librarian (SP.19.14), this proposal does not specify the composition of the advisory committee or the advisory process. Instead, it provides an opportunity for faculty from the department to participate in the search carried out by the dean, which typically involves other interested parties.

Other proposed changes to Sections 2 and 3 would provide transparency to avoid potential conflicts of interest. Specifically, a) the chair or head of the department would continue to be

an *ex officio* member of the departmental executive or advisory committee, but not chair that committee; rather, the chair of the committee would be chosen by and from elected members (Sections 2 and 3); b) the executive committee would advise on the annual appointment of the chair (Section 2); c) the performance of the head would be reviewed annually, while still being evaluated formally at least once every five years (Section 3).

A proposed change to Section 4 would provide another opportunity for faculty to vote on a change of the administrative organization of the department. Specifically, the revision would add the initial appointment of a department chair or head to the circumstances in which the administrative organization of the department may be changed from a chair to a head or from a head to a chair.

### RECOMMENDATION

The Senate Committee on University Statutes and Senate Procedures recommends approval of the following revisions to the *Statutes*, Article IV, Section 1, Section 2, Section 3, and Section 4.

### 1 ARTICLE IV. DEPARTMENTS

- then the department may appeal for a ruling directly to the dean and the executive committee
- of the college and, when the chancellor/vice president considers it proper, to the

- 17 chancellor/vice president, who shall make a decision after appropriate consultation with
- 18 <u>interested parties</u>.
- 19 c. A department may be organized either with a chair or with a head. A reorganization of the
- administration structure of a department from a chair to a head, or a head to a chair, may be
- 21 accomplished only by Section 4 of this Article.

## Section 2. Department Organized with a Chair

### Section 3. Department Organized with a Head

The head of a department shall be appointed without specified term by the Board of Trustees on recommendation by the chancellor/vice president, with the concurrence of the president, after confidential consultations with the dean of the college, and all members the advisory committee of the department, and the faculty of the department-concerned. The department faculty may choose to elect members of the advisory committee for staggered twoor three year terms At least one-half of the members of the departmental advisory committee shall be elected from those faculty members who have at least a 50-percent salaried appointment in the university. In a department which that has a faculty of not more than five members, the advisory committee shall consist of the entire faculty. ## Section 4. Change of Departmental Administrative Organization

Prior to the initial appointment of a department chair or department head, or On on the written request of at least one-fourth of the faculty of the department, as defined in Article II, Section 3a(1), and in no case fewer than two faculty members, that the form of the administrative organization of the department be changed from a chair to a head or from a head to a chair, the dean shall call a meeting to poll the departmental faculty by secret written ballot whether the form of the administrative organization of the department should be changed from a chair to a head or from a head to a chair. The names of those making the request shall be kept confidential by the dean. The dean shall transmit the results of the vote along with the dean's own recommendation to the departmental faculty and to the chancellor/vice president together with the dean's recommendation. If a change of administrative organization is voted approved, the chancellor/vice president shall thereupon transmit this vote the results of the vote of the faculty along with the recommendations of by the dean and of the chancellor/vice president to the departmental faculty and to the president for recommendation to the Board of Trustees. Faculty of the department may communicate with the Board of Trustees in accordance with Article XIII, Section 4d of these Statutes.

SP.20.23 Proposed Revisions to the *Statutes*, Article I, Section 5 – Chancellors and Vice Presidents, Article II, Section 3a(1) – Faculty Role in Governance, and Article III, Section 1g – The University

### **BACKGROUND**

Articles II and III of the *Statutes* specify that the faculty of the university includes those administrators who are in the direct line of responsibility for academic affairs, specifically directors, deans, the provost (vice chancellor for academic affairs), chancellor/vice president, and president. Department chairs and heads are not specified in this direct line of responsibility in II.3, though their duties in Article IV indicate such responsibilities.

The Statutes also specify that at least once every five years there shall be evaluations of the department chair (Article IV, Section 2a), the department head (Article IV, Section 3a), the dean of a college (Article III, Section 3b), and the campus librarian (Article VI, Paragraph e). The Statutes do not currently provide for regular evaluations of the vice chancellor for academic affairs and provost and only recently (ST-77, approved by the Board of Trustees in November 2020) provide for a "formal review" of the chancellor/vice president.

The following proposed revisions to *Statutes* would establish clearer language, addressing both matters, establishing and clarifying the senate's role in the advice and review process of appointing and retaining chancellors, vice chancellors, and provosts. They also clarify the role of department chairs and heads in the direct line of responsibility for academic affairs. Evaluation of an administrator, especially one who is in the direct line of responsibility for academic affairs, is essential for the good of an organization, giving members of the organization an opportunity to voice their suggestions and recommendations. The proposed policy changes are not directed at any individuals currently in these affected positions. SP recommends, therefore, that a performance evaluation be implemented at least once every five years *after* the next initial appointment of the vice chancellor for academic affairs and provost or the chancellor/vice president, unless the incumbent vice chancellor or chancellor agrees otherwise. We further recommend that each university develop general procedures to guide it in its implementation of the evaluation.

### RECOMMENDATION

The Senate Committee on University Statutes and Senate Procedures recommends approval of the following revisions to the *Statutes*, Article I, Section 5; Article II, Section 3a(1); and Article III, Section 1g. Text to be deleted is struck through and text to be added is underlined.

SP.21.09 Revision to the *Bylaws*, Part F.5

#### **BACKGROUND**

At its November 12, 2020 meeting, the University of Illinois Board of Trustees approved a package of revisions to the *Statutes*, ST-77, which included revisions to Article I provisions that govern the review of University Chancellors, specifying a periodic "formal review" process distinct from the routine annual review of the chancellors.

At its February 8, 2021 meeting, the Senate approved SC.21.08, a resolution designed to address this new formal review step and provide for future formal reviews of the Chancellor: "The Senate Executive Committee shall serve as the review committee for the current (2020-2021) Review of the Chancellor and the Senate Committee on University Statutes and Senate Procedures shall be directed to recommend revisions to the Senate *Bylaws* to articulate the mechanism, consistent with the recently amended *Statutes*, for the Senate to use in future formal reviews."

The proposed revisions below build on the current language in the *Bylaws* F.5 that provides for the Senate's input in the appointment of a new chancellor, establishing a parallel model for the new "formal review" process. In addition, SP offers a proposed revision to the same section, revising the final sentences to clarify how campus constituencies may participate in these processes. Finally, F.5 has been given a title, in keeping with F.1-4, each of which are titled.

### **RECOMMENDATION**

The Senate Committee on University Statutes and Senate Procedures recommends the approval of the following revisions to the *Bylaws*. Text to be deleted is struck through and text to be added is underlined. Adoption of amendments to the *Bylaws* requires a two-thirds vote of the Senate.

### **REVISION TO THE BYLAWS, PART F.5**

- 1 Appointment and Formal Review of the Chancellor. The Senate shall determine the
- 2 composition of a committee selected by the Senate to advise the President on the occasion of
- 3 the appointment of a new chancellor, or on a formal review of an incumbent chancellor as
- 4 <u>initiated by the President via the Statutes Article I, Section 5 shall be determined by the Senate.</u>
- 5 Such a The Ecommittee will shall include faculty, academic professional, and student members,

- 6 elected in accordance with Article VI, Section 11 of the Senate Constitution, and other

### RS.22.01 Resolution to Review Policies on Classroom Contact Tracing

WHEREAS the University of Illinois has established itself as a world leader in its response to the COVID-19 pandemic in educational settings—in part through its development of a saliva test for COVID-19 and its use of the Safer Illinois App to monitor building access and help with contact tracing; and

WHEREAS the University of Illinois has been able to return to in-person teaching in part due to the extremely high levels of vaccination within its populations; and

WHEREAS effective contact tracing has been an integral part of the line of defense that the University of Illinois has been using in its past reactions to the COVID-19 pandemic and is viewed by most epidemiologists as an important ingredient to a successful response; and

WHEREAS COVID-19 and the Delta variant remain serious threats to public health today in our region and throughout the world and other variants are likely to emerge and make continued contact tracing an important part of the University of Illinois's response to COVID-19 for years to come; and

WHEREAS at the University of Illinois Urbana-Champaign, as part of the "new normal" for inperson teaching, in-person instructors play—and will continue to play—an important role in enforcing various COVID-19 protocols and enhancing the safety and health of the campus community (especially in the classroom and related educational settings); and

WHEREAS in-person instructors are, for example, empowered by the University to check the entry permission status of all the students in the classroom and act upon infractions; and

WHEREAS in-person instructors are also empowered by the University to check the masking of all the students in the classroom and act upon infractions; and

WHEREAS in-person instructors here at UIUC, as front-line personnel with numerous health safety oversight powers as noted above, should also be kept abreast of best practices to expedite effective contact tracing in the classroom and related educational settings; and

WHEREAS some institutions, such as the University of Illinois at Chicago's School of Public Health, have developed valuable resources for in-person instructors to assist contact tracing in the event of a positive case emerging in their classrooms; and

WHEREAS robust data collection regarding close contacts in classrooms has proven to be of considerable benefit in some educational settings, where it has been used to mitigate the risks of classroom transmission and to assure instructors that all possible measures are being taken to keep classrooms safe; and

WHEREAS the publication of such data, for example about case numbers of possible classroom transmission, may help to ameliorate many fears about classroom safety on the part of instructors and students, as when UIC contact tracers shared data that showed that, in the first four weeks of the Fall 2021 semester, the 90 students who tested positive had been present in a total of 192 classes within the window of their infectiousness but that contact tracers found only one *possible* case of transmission, who was an unvaccinated student;<sup>2</sup> and

WHEREAS the data collected by UIC contact tracers suggest that classrooms that follow the current classroom masking and building access protocols in place at both UIC and UIUC and have similarly high vaccination rates are currently very safe and that classroom transmission is currently very likely either very low or non-existent at UIUC—even though circumstances may change as the virus evolves and specific data from UIUC could help establish that more clearly;

BE IT THEREFORE RESOLVED that in order to build on the University of Illinois's past record of success, the Academic Senate's Executive Committee work with the campus administration to form an ad-hoc committee, comprising relevant stakeholders from across the campus to examine current practices and protocols related to data collection and dissemination in regard to contact tracing in the classroom and related educational settings;

BE IT FURTHER RESOLVED that, more specifically, the ad-hoc committee consider both the CDC's guidelines for IHEs (institutions of higher education) regarding "policies and procedures to support expedited determination of exposure risk and close contacts" as well as the practices of other IHE's related to contact tracing in the classroom and other educational

settings in order to recommend steps that are judged to be both beneficial and feasible in the specific UIUC context that instructors can take to help contact tracers quickly and effectively identify potential close contacts in their classrooms<sup>4</sup>;

BE IT FURTHER RESOLVED that the committee should explore whether and how anonymized information about every case where a student has tested positive should be maintained in a secure campus database, in which course-related data is collected, including all contact tracing and other risk mitigation steps that may have been taken in each class, for possible use in evaluating the success of these steps and for developing long term risk mitigation strategies to improve the health and safety of our classrooms and related educational settings during the ongoing pandemic, and for providing the university community with regular updates of relevant classroom contact tracing metrics;

BE IT FURTHER RESOLVED that the committee should report on its findings and recommendations to the Academic Senate, ideally before the end of Fall term but no later than the first Senate meeting of Spring term, for discussion.

This program is part of an approved pilot program for a dual degree pathway which has undergone discussions and approvals from the office of the provost, office of the registrar, undergraduate admissions, DMI, and representatives from each college in the areas of faculty, unit heads, advising, administration, college deans, and financial operations. Since this program is not revising any program requirements beyond what is usual conducted, it will be approved by the workflow representatives in each college, the office of the provost, and the office of the registrar without additional workflow approvals needed, per conversations with appropriate parties mentioned previously.

- 1. The proposed program differs from the current approach to dual degrees by providing a path for prospective freshman and off-campus transfers to apply into the dual degrees simultaneously. It also involves financial agreement between colleges for splitting tuition rather than relying on split semesters. Overall, it demonstrates an intentional and coordinated effort between both units to students pursuing dual degrees in Dance and Kinesiology.
- 2. See email attachment of approval from AHS and FAA chief budget officers, along with the Provost's Office regarding the financial agreement.
- 3. Tuition structure is clarified within this proposal below. No new, additional resources are required to administer this program.
- 4. A student who elects to drop the dual degrees and pursue only one degree may do so at any time, which would go into effect for the upcoming term. Since no degree requirements are altered and students are pursuing courses in both units every term following a regular timeline, this would not impact degree progress.
- 5. See attached MOU as evidence of approval from FAA and AHS Deans to support this initiative. Please note that the program proposal now serves as an updated agreement between Kinesiology/AHS and Dance/FAA. At any time, either unit/college may request a deactivation to the registrar's office and both units/colleges will approve the deactivation for the upcoming catalog year, still allowing any currently enrolled students to complete the dual degrees per the agreement.

This Dual Degrees (DD) pathway enables students to earn a BA in Dance and BS in Kinesiology in a more seamless manner than current policies allow for.

Students will complete all individual degree requirements for each major, except for FAA 101 which will be waived as a FAA college orientation course. Students will still take both a Dance orientation course (DANC 150) and Kinesiology orientation course (KIN 125) and FAA 101 is commonly waived for transfer students. The 15 hours of required non-Dance classes for the BA Dance will be met with Kinesiology courses and the 18 hours of correlate area studies for the BS Kinesiology will be met with Dance classes. This DD adheres to the campus policy that 30 additional credit hours beyond the first degree be obtained for dual degrees. Both degrees will be awarded concurrently. Advisors have prepared a sample schedule which demonstrates how students could complete the 158 credit hour program. As with most dual degrees, it is designed as a five-year program but may be completed

on an accelerated path in as few as four years and two summers, if students enter as freshman, have their language requirement already completed, and required course sequencing does not conflict. The time to degree completion is largely dependent upon when students begin the programs (fall of first-year recommended).

Prospective freshman and off-campus transfer students will apply directly to the DD. Approximately August 1st, the incoming students will have their program code changed on the Banner student records to dual degrees with a 1D program code for Dance as primary and a 1D program code for Kinesiology as secondary. The application record will not be updated. Enrollment reports will reflect Dance as primary, but with the corresponding major codes the DD students will be easily identifiable for advising and enrollment count purposes. Students will have priority access to courses in both units. A manual split for tuition revenue will occur, with FAA keeping the differential program tuition and both colleges splitting the base tuition accordingly for R/NR/I. Messaging students will clearly identify the benefits of enrolling in this pathway, the time to graduation, and the differential tuition cost. After consultation with the office of financial aid, there were no concerns voiced over this arrangement. Students will remain in FAA as primary for their entire degree, although AHS will provide advising and consider access to scholarships or other programs as residential students would be supported whenever possible.

Both departments concurred that the primary advantage to earning dual degrees in Dance and Kinesiology would be to increase the competitive advantage in future career opportunities that students would likely still have pursued with a single degree. The number of open, free electives available to students in this path empowers students to potentially elect a minor or a sub-specialty of choice.

The Dance curriculum enables students to become certified Yoga instructors which may be a desirable career opportunity for students in this dual degree program.

Kinesiology currently offers K-12 teacher certification for physical education and an endorsement in dance may be added, enabling students in this pathway to complete a five-year program earning dual degrees with physical education teacher certification and an endorsement in dance. This would provide students an opportunity to teach both Dance and Kinesiology in the U.S. educational system.

Physical therapy preparatory coursework could also be pursued through free electives although students would likely require a fifth year due to the demands of both majors along with the preparatory coursework. Earning a Doctorate in Physical Therapy was identified as an appealing profession that many students are drawn to and would be greatly served through the preparatory coursework available in this dual degree program.

The Texas A&M Career Center states that Kinesiology Dance Science majors become, "professionals who are employed by dance companies and dance training facilities throughout the world to devise effective training programs as well as advise dancers regarding nutrition and injury prevention/care" and report potential professions such as "Dance Medicine Physician, Dance Teacher, Massage Therapist, Nutritionist, Physical Therapist, Trainer, Pilates Instructor, Researcher, and more" (https://careercenter.tamu.edu/Resources/Exploring\_Career\_Paths/Careers-Salaries-and-Employers-by-Major/Kinesiology-Dance-Science).

The Elon University Dance Science program states that graduates "pursue careers as dance teachers, conditioning and fitness coaches, kinesiotherapists, and researchers in a variety of fields including biomechanics, physiology, somatics, and psychology. This degree prepares students for graduate study in a variety of disciplines including physical or occupational therapy, dance education, dance science, exercise science, medicine" (http://www.elon.edu/e-web/admissions/majorsheets/dance\_science.xhtml).

The application mentioned that there are similar programs in other institutions, which suggests the potential for this program. The application said "This DD pathway enables students to earn a BA in Dance and BS in Kinesiology in a more seamless manner than current policies allow for." It was unclear to me how the previous program differs from the proposed program.

Additionally, what would happen if a student is part-way through the dual program and decides that they only want to complete one of the majors, given that they would not have the appropriate electives. Is there a way for them to do that without adding substantial time to their degree program?

## MEMORANDUM OF UNDERSTANDING **COLLEGE OF FINE AND APPLIED ARTS** AND

### COLLEGE OF APPLIED HEALTH SCIENCES

This Memorandum of Understanding (MOU) is entered into as of the date of final executing signature, by and between, the College of Fine and Applied Arts (FAA) and the College of Applied Health Sciences (AHS) at the University of Illinois, to develop a dual degree pathway between the Bachelor of Art in Dance and Bachelor of Science in Kinesiology.

FAA and AHS (together "The Units") are effectuated through the development of a positive, professional, and collaborative relationship between these two University of Illinois Units, agree to formalize their relationship as further defined below.

This MOU addresses the basic relationship, roles, and responsibilities of the Units and leaves for later agreement additional terms as needed for the evolving nature of any partnership and leaves for further clarification to be defined with the policies and procedures of both of the Units.

#### I. Purpose

- A. To develop, enhance, and maintain a dual degree pathway for undergraduate students through coordinated efforts between the units
- B. To identify a sample plan of study for students declaring a Bachelor of Arts degree in Dance and a Bachelor of Science degree in Kinesiology
- C. To establish the processes for primary and secondary degree declaration, identifying terms for college residency, acknowledging that only the primary degree drives tuition generated
- D. To determine a collaborative approach to admissions for prospective freshmen, offcampus transfer students, and inter-college transfer (ICT) students
- E. To identify a shared approach for marketing and recruitment communications to the dual degree pathway

#### II. **Expectations**

- A. The Units agree to meet no less than one time per academic year to discuss issues that fall within the scope of this MOU.
  - i. The Units shall designate "Coordinators" who serve as primary administrative contacts between the Units. To the maximum extent possible and unless otherwise approved by the Units, all administrative communications between the Units is made via the Coordinators.
  - ii. The Coordinators are empowered to delegate this authority as required.
  - iii. The Coordinators can be reassigned or changed by the individuals within the Signatory roles of this MOU and changes are communicated in writing to the other Units.
  - iv. The Coordinator from Kinesiology will schedule the annual meeting.
  - v. Among the issues to be discussed are enrollment, marketing and recruitment, college residency balances, course registration, and curricula.
- B. Major declaration and initial course access

- i. Students who begin as freshman in Kinesiology: May complete the Dance audition in the fall term and, with a successful audition, receive overrides to Dance classes in the spring term. They may also audition in the spring term.
- ii. Students who begin as freshman in Dance: Will complete ICT application to Kinesiology in spring of freshmen year. Dance advisors may request overrides to first-year Kinesiology major courses for students submitting their ICT application to Kinesiology.
- iii. Dance/FAA will accept ICTs in spring of freshman year, contingent on successful fall audition, and agreement of other college
- iv. Both Units will encourage and support students to complete dual degree paperwork for both colleges in the first year so dual degrees are declared for fall of sophomore year.

### C. Curricula

- i. Students with primary and secondary degrees automatically receive major course access for both.
- ii. Both Units agree that studio and lab space is available in major courses for both degrees for 15 additional students through this partnership, and enrollments will be reviewed annually together. No additional resources are needed with this maximum if current resources are maintained.
- iii. BA Dance 'Hours in non-Dance classes, chose in consultation with an advisor' also known as 'focused electives' (15 hours) will be met through Kinesiology degree requirements
- iv. BS Kinesiology 'Correlate Area Studies' (18 hours) will be met through Dance degree requirements
- v. Students who begin their first year in Kinesiology will be exempt from FAA 101
- vi. Students will need to earn 158 hours minimum to earn the dual degrees, which adheres to Student Code 3-801 of 30 hours additional beyond the first bachelor's degree
- vii. The first bachelor's degree and additional bachelor's degree will be awarded concurrently

### D. College Residency and Tuition Flow

- i. All current campus and colleges processes and policies will apply
- ii. Students' primary major will drive tuition and thus the following plan for college residency will be followed, with the responsibility on the college residency is switching *to*:

iii. Students are not eligible to continue receiving any Talented Student Award scholarships (awarded from the UIUC Department of Dance or College of Fine & Applied Arts) while Dance is the secondary major. AHS scholarship eligibility is dependent on type of scholarship.

#### E. Other

- The BA in Dance requires a capstone with faculty committee review, and dual degree candidates will include one faculty member from the Department of Kinesiology
- ii. Both Units will identify college and unit specific web presence and materials to demonstrate the collaboration. Dance will take primary lead on development of marketing materials, with input and approval from Kinesiology, and acknowledgement that joint printed materials may have a shared cost.
- iii. Both Units will collaborate to offer inter-college transfer support and materials targeting first-year students not enrolled in FAA or AHS

### III. Term, termination, and Modification

- A. This MOU is effective upon the last date of signing below.
- B. This MOU remains in effect for an initial period of two (2) years, after which it may be renewed upon mutual agreements by The Units.
- C. This MOU may be modified in writing and signed by the Unit Coordinators.
- D. Any Unit may unilaterally withdraw any time from this MOU by providing written notice to the other Unit. This MOU is considered terminated thirty (30) days from notice from the withdrawing Unit. Even if terminated, all students currently pursuing dual degrees in Kinesiology and Dance will still be supported to complete both curriculums and degrees.

#### V.GENERAL

A. **Promotion.** No Unit is permitted to use the other Units name in any advertising, promotion, or literature without first obtaining written consent of the Unit.

B. Entire Understanding and Amendment. This Understanding is the entire understanding between the Units and supersedes and rescinds all prior agreements relating to these subjects. The Units certify the terms of this understanding are binding and its duly authorized coordinators signed this understanding after having carefully read and understood the same.

### Response to feedback from Senate EPC Chair & Subcommittee Chairs

June 23, 2021

 The proposal talks about K-12 certification. Can students receive teacher certification in both dance and kinesiology in this dual program, or just one area? Or not at all? This was unclear to us.

This has been clarified in the 'employment outlook' section. Students pursuing a 5-year plan for the BA Dance/BS Kinesiology dual degrees would be well prepared to pursue Physical Education (PE) teacher licensure & Dance endorsement. PE teacher licensure includes minimal credit hours beyond the total hours required for BS Kinesiology/BA Dance degrees (approx. 3 credit hours), but the free electives students usually pick become fully designated toward the PE curriculum, decreasing their choice and flexibility within the curricula. Students also need to participate in school placements, which could be completed within a five-year program with the last semester being fully embedded in a school. Required coursework for a Dance endorsement added to the PE teacher licensure is embedded into the dual degree pathway (18 semester hours) and students would need to pass the Dance subsequent teaching endorsement Dance 209 test and first hold a Professional Educator License (PEL) or Educator License with Stipulations endorsed in a teaching field (such as PE) to add the Dance content area endorsement.

2. Are students expected to earn both degrees in four years? The 4-year plan Nicole sent me implies four years (attached). Are we sure this can happen? The pre-reqs for some of the courses are not in the 4-year plan. The pre-reqs should be explained somewhere. These can also live in the curriculum table (Notes section).

Original language stated that the program could be completed in "as few as four years and two summers, if they enter as freshman." Language added to this statement in program description to clarify that, as with most dual degree programs, it was designed as a five-year experience but it may be possible to complete it in as few as four years and two summers, if students enter as freshman and required course sequencing does not overlap.

### Regarding prerequisites:

Response from KIN academic advisor, Cassie Meinert, 6.23.21: Amy and I actually asked about this prerequisite recently so I will copy the MCB department response below. Our students have never been required to take the prerequisite courses listed but they do provide supplemental CHEM material for students to review if they would like/need to. That said, many of our students do end up taking CHEM in their freshman year based upon their career intentions (PT, Medicine, etc.). With this, the schedule that we have OK'd is still okay and correct in regard to these prerequisites, according to the language from the MCB department.

Response from MCB: "We are still supplying the necessary chemistry and also provide supplemental information for students to access."

Because there is no change or difference in requirements for the dual degree sequence compared to the BS in Kinesiology, the required MCB courses do not enforce the prerequisite and provide the needed student support to excel in the course, and there is an opportunity to complete a Physical Science General Education course such as Chemistry in the summer after freshman year, no changes are made to the curriculum table or notes section.

- 3. If admitted to this program and a student needs five years to complete both degrees, what are the implications, if any, on financial aid?
  - Students would be advised to consult with financial aid when accepting an offer to join the dual degree pathway. Some common aid types include Illinois Commitment which covers four years/eight semesters only, Illinois Promise has the same but also allows for petitions to receive funding beyond 4 years. MAP (Monetary Award Program) grants cover up to 135 semester credit hours (~9 semesters). The Federal Pell Grant is eligible for 12 full-semester terms (~6 years). Financial aid is dependent on a full package, unique to each student and no claims about financial aid are made in the proposal for this reason.
- 4. We feel the advertising of this program will be really important...that's why all the questions. We agree and the communication of implications to students will be important to have both units review (which they have agreed to) before anything is sent or published for this reason.
- 5. With the 4-year sample schedule Nicole sent me, taking the days and times of when courses are listed right now:
  - a. First year, Spring KIN 122 conflicts with DANC 160 on F at 11a. Online asynchronous option of KIN 122? KIN 122 has online asynchronous options in fall and spring. Additionally, it may be completed in the summer after freshman year if needed.
  - b. Sophomore year, Fall- MCB 244/245 has a CHEM 101 or 102/103 Prereq which has a prereq of MATH 114; or credit. See above note regarding prerequisites. The sample schedule includes Quantitative Reasoning I general education (a higher level than MATH 114) taken in summer after freshman year, prior to MCB and MCB will provide needed chemistry knowledge within the courses.
  - c. Sophomore year, Spring MCB 246/247 also has CHEM 101 or 102/103 prereq which has MATH 114 prereq. See above note regarding prerequisites. The sample schedule includes Quantitative Reasoning I general education (a higher level than MATH 114) taken in summer after freshman year, prior to MCB, and Quantitative Reasoning II in the same term as MCB 246/247. MCB will provide needed chemistry knowledge within the courses.
  - d. Junior Year, Fall- Conflict with DANC 362 and KIN 352 MW 3-3:50pm. FA 19 did not pose a conflict, but FA 20 and FA 21 have. The Dance curriculum is flexible and DANC 362 could be taken the following fall (or spring, if offered) if it presents a conflict in future years.
  - e. Junior Year, Spring DANC 260 listed as an option but it conflicts with KIN 355. Both courses are offered fall and spring terms with no conflicts in SP 21, FA 21 or the FA 19 and SP 19 which the sample schedule was based off of. Since there was a conflict in SP 20, DANC 260 could be delayed a semester if needed.
- 6. With the above, how will the advisors work together to make sure students can maneuver through this in four years? Or should we not imply two degrees in fours years is a <u>definite</u> possibility?

The time to degree completion is largely dependent upon when students begin the programs. Students who begin after freshman year may need additional semesters to complete the dual degrees (particularly with regards to PE certification).

When the sample schedule for the 4 years and two summers was developed (winter 2019-2020), advisors from both units noted required courses each summer and the times offered finding no conflicts. Therefore, the report from March 2020 stated as such. The BA Dance curriculum is quite flexible and was designed to accommodate dual degrees, so a copy of the KIN required course sequences and schedules was developed and Dance agreed they would be able to adhere to this. In April 2021, the Dance department had some planned changes to core courses and conducted an additional thorough review of the required course times in KIN and confirmed the 4-year sample schedule would work. Similarly for students on a 5-year track pursuing PE licensure with Dance endorsement within the Dance/Kinesiology dual degrees, the timetables were reviewed in March 2021 to confirm the PE courses did not overlap.

The sample schedule reviewed by EPC was not submitted as part of the proposal and is considered an advising tool, subject to change. Professors sometimes request changes to the times their courses are offered and as such, future course time conflicts could arise. We will update language about the program completion timeframe to avoid any perception of guarantees. We will also have the advisors meet to establish a regular five-year course plan for students who do not wish or are not able to follow the accelerated pathway.

Advisors from Dance & Kinesiology have collaborated on an almost-monthly basis since October 2019 and have a willingness to closely support students moving through this pathway, beginning with new student registration.

7. In the CIM-P curriculum table, what does the "3" mean in KIN 140, 150, 20, 259 and 340? There is not a Notes table that I can see in CIM-P:

This was an error when copying the degree table from the KIN program of study. KIN uses the  $^3$  to notate major courses which also fulfill General Education requirements. I have deleted the  $^3$  notations from the DD degree requirements table.
