Program Justification

Why are these changes necessary?

The revision to the Bachelor of Music in Instrumental Music is the result of five years of conversation, evaluation, and study. We've compared our current curriculum to our peer institutions in music, listened to our students and their concerns, held many discussions within the ten areas of the School of Music, and have evaluated what this means for students receiving music degrees in the twenty-first century, knowing many of our music students will be creating their own niche in the music industry. The revisions led to School-wide conversations that focused on attracting a more diverse music student, and they addressed a need to provide music majors more tools to be successful early on in their program. We have seen talented students leave music within the first year because of difficulties in Music core courses like music theory and musicianship (aural skills). Last spring, we revised our core music theory sequence to spend more time on music literacy, plus introduce music technology, in the first semester of music theory.

Conversations also addressed how to make our BMUS programs more relevant for today's music major by focusing more on the program's major, and allowing more flexibility in course selection, especially with courses outside the School of Music. This includes the ability to pursue minors and degrees in other colleges more easily. We know from talking to prospective music majors and their parents that many talented students actively seek music programs which offer these types of opportunities without constraint.

The BMUS Music Core of music theory, musicianship (aural skills), musicology (music history), and keyboard (group piano) does not change. Some revisions outside of the Music Core are a result of course substitutions (through petition) we have been allowing the last few years due to new courses, retired courses, or faculty retiring or leaving the School of Music. Other revisions are the result of the large voice our School of Music faculty had in curricula improvements.

Other revisions include a new rubric for Music, MUSC, which now contains all of our applied lesson courses and ensembles. It replaces MUS applied lesson courses and ensembles. (We ran out of numbers at the 400- and 500-levels in MUS.) These course substitutions are reflected in the BMUS program revisions.

The BMUS revisions have gone through two full faculty approval votes in the last two years. A year and a half ago, we approved curricula revisions for all six BMUS programs; last year during the pandemic, we approved a new first-year seminar course for all music majors; and last spring, we approved our revised core music theory sequence. We are now reevaluating our core musicology sequence and how it relates to an unbiased history of music, both inside and outside of the Western canon.

Additional information regarding the revisions to the BMUS in Instrumental Music is below:

- (1) The minimum degree hour requirement will change from a "minimum of 130-hours" to a "minimum of 120-hours." This revision meets the 40-hour upper-level course minimum, which includes courses at the 300- and 400-level, plus courses that have a two-course prerequisite (MUS 201, 202, 207, 208).
- (2) Add MUS 100 (First-year Seminar for Music Majors). This POTB course begins as FAA 101 (POTA) finishes and meets one day a week in the same day/time slot as the FAA 101 lecture. The course allows us to connect with our new music majors, see how they are doing physically and emotionally, answer questions they have about the degrees they are in, discuss what it means to be a music major, including the day-to-day stresses of practice, homework, concerts, and class attendance. This is a chance for us to address problems more quickly, reinforce campus resources, and bring in key personnel, like our new FAA embedded counselor, to converse with our students.
- (3) Add one credit to MUS 110 (Introduction to Art Music: International Perspectives) and one credit to MUS 208 (Musicianship IV). MUS 110 meets for four hours a week for two credits right now, and MUS 208 meets for three hours a week for one credit. This credit change better reflects the amount of work students are doing in both courses and this echoes the sentiments of our students. These are spring semester courses; course edits have already been submitted to CIM.
- (4) Move hidden requirements out of the Footnotes section and put them into the curriculum table. Create Option tables for transparency. There is more transparency when course requirements are listed in a curriculum table. This includes the chamber music requirement for brass and string performance majors and MUS 454 for keyboard majors, both currently in the footnotes section. The new Option tables also better identify required courses for woodwind, brass, percussion, string, and keyboard performance majors.

- (5) Eliminate the six hours of Advanced Musicology and six hours of Advanced Music Theory. The new Instrumental Music Studies core requires students to take a minimum of three hours of Advanced Musicology or Music Theory. Within the five instrumental options of this degree (woodwind, brass, percussion, string, keyboard), the remaining 19 hours are covered in upper-level music course electives, open electives, and/or courses which students have been taking over the last number of years at the advisement of their applied teachers, who also serve as advisors for their students.
- (6) Delete the Minor Applied Lessons requirement for all instruments except Keyboard (piano, harpsichord, organ). Only one School of Music Area, Keyboard, feels the need to require their students to take a minor instrument. All other Areas want their students to have more choice in their performance curriculum, plus spend their applied lesson practice time on their primary instrument and not a secondary instrument. This is an outdated requirement many other music schools eliminated years ago.
- (7) Reduce the required Major Ensemble credit hours for Keyboard majors from eight hours to four hours. Over the last ten years, most of the Keyboard students (piano, organ, harpsichord) have been fulfilling this requirement by singing in a choir or playing a wind or percussion instrument in band or orchestra—not playing their major instrument, as there are not enough ensemble positions for Keyboard players. In addition, Keyboard faculty feel their majors need to focus on their primary instrument during their junior and senior years, as all junior and senior keyboard recitals are required to be memorized. Since these keyboard majors are required to take eight additional hours in applied lessons, there is no difference in overall hours for the program when compared to the other instrumental options (woodwind, brass, percussion, and string).
- (8) Add MUSC 300 (Junior Recital) and MUSC 400 (Senior Recital) for zero credit each. While both a junior and senior recital are required for Instrumental Music, Voice, and Jazz Performance majors, and a senior recital is required for Music Composition majors, there is no course to mark these degree milestones on a student's transcript.

Completion of both MUS 313 and MUS 314 meets the general education Humanities and the Arts requirement.

String majors will register for four semester hours of applied music in the first year; thereafter, string majors will register for three semester hours of applied music and one semester hour of MUS 267%7CCODE in the second, third, and fourth years. Brass majors will register for three semesters hours of applied music and one semester hour of MUS 267%7CCODE each semester for all four years. All other instrumental majors register for four semester hours of applied music each semester.

Completion of both MUS 313 and MUS 314 meets the general education Humanities and the Arts requirement.

All students must demonstrate keyboard competency when they audition, by proficiency examination when they matriculate, or by enrolling in MUS 172 and/or MUS 173.

All music majors are required to participate in an approved ensemble every semester in residence. All string majors must audition for the orchestras at the beginning of each fall. For a complete list of approved ensembles, please refer to the Undergraduate Music Handbook.

All students must demonstrate keyboard competency by examination when they matriculate or by enrolling in MUS 172 and/or MUS 173. Keyboard performance majors demonstrate keyboard competency by successfully completing MUS 454.

Woodwind, brass, percussion, and string majors register for three credit lessons each semester for a minimum of eight consecutive semesters, unless otherwise advised by the applied teacher (MUSC 110-117, 120-130, 410-417, 420-430). Keyboard majors register for four credit lessons each semester (MUSC 101-103, 401-403).

Instrumental Music majors are required to be in a major ensemble each semester of residence; a maximum of 10 hours of ensemble may be applied to the BMUS Instrumental Music degree. Refer to the Undergraduate Music Handbook for a list of approved ensembles. Concurrent registration in one of the orchestras (MUSC 475 or MUSC 476) is required for all classical violin, viola, cello and double bass majors registered for lessons (MUSC 110-113 and MUSC 410-413). Keyboard performance majors take only four semesters of ensemble.

The students may choose from MUS 400, 405, 407, 408, 409, 410, 411, 412, 413, 414, 415, 416, 418, 421, and 426.

The Language requirement may be satisfied by successfully completing a third-semester college-level course in a language other than English; successful completion, in high school, of the third year of a language other than English; or demonstrating proficiency at the third-semester level in a language proficiency examination approved by the College of Liberal Arts and Sciences and the appropriate department.
- 3. Completion of both <u>MUS 313</u> and <u>MUS 314</u> meets the general education Humanities and the Arts requirement.
- 4. String majors will register for four semester hours of applied music in the first year; thereafter, string majors will register for three semester hours of applied music and one semester hour of MUS 267 in the second, third, and fourth years. Brass majors will register for three semesters hours of applied music and one semester hour of MUS 267 each semester for all four years. All other instrumental majors register for four semester hours of applied music each semester.
- Concurrent registration in MUS 250 is required for all students who register for any of MUS 183-MUS 186 and MUS 483-MUS 486.
- Keyboard majors are required to complete only 6 hours of minor applied music.
- 7. All music majors are required to participate in an approved ensemble every semester in residence. All string majors must audition for the orchestras at the beginning of each fall. For a complete list of approved ensembles, please refer to the Undergraduate Music Handbook.
- All students must demonstrate keyboard competency by examination when they matriculate or by enrolling in MUS 172 and/or MUS 173. Keyboard performance majors demonstrate keyboard competency by successfully completing MUS 454.

Instrumental Music Footnotes (revised)

- Six hours of general education requirements in the Humanities and the Arts are met by courses required in the BMUS degree (MUS 313 and MUS 314).
- 2. The Language requirement may be satisfied by successfully completing a third-semester college-level course in a language other than English; successful completion, in high school, of the third year of a language other than English; or demonstrating proficiency at the third-semester level in a language proficiency examination approved by the College of Liberal Arts and Sciences and the appropriate department.
- 3. Completion of both <u>MUS 313</u> and <u>MUS 314</u> meets the general education Humanities and the Arts requirement.
- All students must demonstrate keyboard competency when they audition, by proficiency examination when they matriculate, or by enrolling in MUS 172 and/or MUS 173.
- Woodwind, brass, percussion, and string majors register for three credit lessons each semester for a minimum of eight consecutive semesters, unless otherwise advised by the applied teacher (MUSC 110-117, 120-130, 410-417, 420-430).
 Keyboard majors register for four credit lessons each semester (MUSC 101-103, 401-403).
- 6. Instrumental Music majors are required to be in a major ensemble each semester of residence; a maximum of 10 hours of ensemble may be applied to the BMUS degree. Refer to the Undergraduate Music Handbook for a list of approved ensembles. Concurrent registration in one of the orchestras (MUSC 475 or MUSC 476) is required for all classical violin, viola, cello, and double bass majors registered for lessons (MUSC 110-113 and MUSC 410-413). Keyboard performance majors take only four semesters of ensemble.
- 7. Students may choose from MUS 400, 405, 407, 408, 409, 410, 411, 412, 413, 414, 415, 416, 418, 421, and 426.
- Keyboard performance majors take a minimum of six (6) credits of applied lessons on a minor instrument: piano, harpsichord, or organ depending on the major keyboard instrument.
