Revision of the Bachelor of Music in Music Composition, School of Music, College of Fine and Applied Arts

Program Justification

Why are these changes necessary?

The revision to the Bachelor of Music in Music Composition is the result of five years of conversation, evaluation, and study. We've compared our current curriculum to our peer institutions in music, listened to our students and their concerns, held many discussions within the ten areas of the School of Music, and have evaluated what this means for students receiving music degrees in the twenty-first century, knowing many of our music students will be creating their own niche in the music industry. The revisions led to School-wide conversations that focused on attracting amore diverse music student, and they addressed a need to provide music majors more tools to be successful early on in their program. We have seen talented students leave music within the first year because of difficulties in Music core courses like music theory and musicianship (aural skills). Last spring, we revised our core music theory sequence to spend more time on music literacy, plus introduce music technology, in the first semester of music theory.

Conversations also addressed how to make our BMUS programs more relevant for today's music major by focusing more on the program's major, and allowing more flexibility in course selection, especially with courses outside the School of Music. This includes the ability to pursue minors and degrees in other colleges more easily. We know from talking to prospective music majors and their parents that many talented students actively seek music programs which offer these types of opportunities without constraint.

The BMUS Music Core of music theory, musicianship (aural skills), musicology (music history), and keyboard (group piano) does not change. Some revisions outside of the Music Core are a result of course substitutions (through petition) we have been allowing the last few years due to newcourses, retired courses, or faculty retiring or leaving the School of Music.

Other revisions are the result of the large voice our School of Music faculty had in curricula improvements. Other revisions include a new rubric for Music, MUSC, which now contains all of our applied lesson courses and ensembles. It replaces MUS appliedlesson courses and ensembles. (We ran out of numbers at the 400- and 500-levels in MUS.) These course substitutions are reflected in the BMUS program revisions.

The BMUS revisions have gone through two full faculty approval votes in the last two years. A year and a half ago, we approved curricula revisions forall six BMUS programs; last year during the pandemic, we approved a new first-year seminar course for all music majors; and last spring, we approved our revised core music theory sequence. We are now reevaluating our core musicology sequence and how it relates to an unbiased history of music, both inside and outside of the Western canon.

Below is additional information regarding the BMUS in Music Composition revision:

- (1) The minimum degree hour requirement will change from a "minimum of 130-hours" to a "minimum of 120-hours." This revision meets the 40-hour upper-level course minimum, which includes courses at the 300- and 400-level, plus courses that have a two-course prerequisite (MUS 201, 202, 207,208).
- (2) Add MUS 100 (First-year Seminar for Music Majors). This POTB course begins as FAA 101 finishes and meets one day a week in the same day/ time slot as the POTA FAA 101 lecture. The course allows us to connect with our new music majors, see how they are doing physically and emotionally, answer questions they have about the degrees they are in, discuss what it means to be a music major, including the day-to-day stresses of practice, homework, concerts, and class attendance. This is a chance for us to address problems more quickly, reinforce campus resources, and bring in key personnel, like our new FAA embedded counselor, to converse with our students.
- (3) Add one credit to MUS 110 (Introduction to Art Music: International Perspectives) and one credit to MUS 208 (Musicianship IV). MUS 110 meets for four hours a week for two credits right now, and MUS 208 meets for three hours a week for one credit. This credit change better reflects the amount of work students are doing in both courses and this echoes the sentiments of our students. These are spring semester courses; course edits have already been submitted to CIM.
- (4) Reduce the Applied Music Lessons requirement from 16 to 8 hours. Since Music Composition students take both applied lessons (instrumental or voice) and composition lessons starting their freshman year, we felt two years of applied study was sufficient. If Music Composition majors wish to continue their applied lesson study, they will be able to do so.
- (5) Replace the Advanced Music Theory (3 credits) requirement with MUS 408 D or MUS 408 E. Music Composition majors need to take at least one of these courses in their curriculum. Section D covers music composed during the first half of the twentieth century, and section E is music composed since World War II.

- (6) Delete the requirement for 14 Hours of Music Theory Electives. Music Composition students will be required to take 12 hours of advanced music theory in the curriculum revision. We would like them to spend more time composing music than taking additional theory electives.
- (7) Delete the two courses in French, German, or Italian requirement (8 hours). This is an antiquated requirement which predates the numerous software and language programs which translate written and aural material from other languages, plus the University has a three-semester language requirement in place. We did not feel it necessary to add another language requirement.

Music Composition Footnotes (current)

- Six hours of general education requirements in the Humanities and the Arts are met by courses required in the BMUS degree (MUS 313 and MUS 314).
- 2. The Language requirement may be satisfied by successfully completing a third-semester college-level course in a language other than English; successful completion, in high school, of the third year of a language other than English; or demonstrating proficiency at the third-semester level in a language proficiency examination approved by the College of Liberal Arts and Sciences and the appropriate department.
- Completion of both <u>MUS 313</u> and <u>MUS 314</u> meets the general education Humanities and the Arts requirement.
- 4. All students are required to enroll in at least one approved performance ensemble each semester in residence, with a maximum of 16 semester hours of such ensemble applicable to the Bachelor of Music degree. For a listing of approved ensembles, please refer to the Undergraduate Music Handbook.
- All students must demonstrate keyboard competency by examination when they matriculate or by enrolling in MUS 172 and/or MUS 173.
- 6. The music theory electives for the third and fourth years are to be chosen from MUS 404 (may be repeated to a maximum of six semester hours), MUS 405, MUS 407, MUS 408 (may be repeated to a maximum of six semester hours in addition to MUS 408, sections D or E), MUS 409, and MUS 499 (may be repeated to a maximum of four semester hours; senior standing in music required). If the curricular emphasis is in music theory, the following will apply: juniors will substitute an additional three semester hours of MUS 408 for MUS 406; seniors will take MUS 299 (two semesters), MUS 405, and substitute an additional 400-level music history course for MUS 406. Note: The 14 hours of theory electives include the six hours of two courses that were retired in Fall 2017: MUS 402 and MUS 425.
- Students who completed two years of French, German, or Italian in high school have met this requirement. Other languages may be chosen with permission of the compositiontheory adviser. Completion of this requirement does not complete the General Education language requirement.

- Six hours of general education requirements in the Humanities and the Arts are met by courses required in the BMUS degree (MUS 313 and MUS 314).
- 2. The Language requirement may be satisfied by successfully completing a third-semester college-level course in a language other than English; successful completion, in high school, of the third year of a language other than English; or demonstrating proficiency at the third-semester level in a language proficiency examination approved by the College of Liberal Arts and Sciences and the appropriate department.
- 3. Completion of both <u>MUS 313</u> and <u>MUS 314</u> meets the general education Humanities and the Arts requirement.
- All students must demonstrate keyboard competency when they audition, by examination when they matriculate, or by enrolling in MUS 172 and/or MUS 173.
- 5. Students register for two-credit applied lessons for a minimum of two years.
- Music Composition majors must be in an ensemble each semester of residence; a maximum of 10 hours of ensemble may be applied to the BMUS in Music Composition degree. Refer to the Undergraduate Music Handbook for a list of approved ensembles.
- 7. The music theory electives for the third and fourth years are to be chosen from MUS 400, MUS 404, MUS 405, MUS 407, MUS 408 (B, C, D, or E, whichever is not taken for the other MUS 408 requirement), MUS 409, and MUS 499 (with advisor approval). Music theory courses may not be used for more than one requirement.
