MINUTES

I. ANNUAL MEETING OF THE FACULTY – CALL TO ORDER

The Annual Meeting of the Faculty was called to order at 3:10 pm by Professor Emeritus H. George Friedman, Jr. serving as the Presiding Officer of the Senate. All University of Illinois Urbana-Champaign faculty members were invited to participate during this portion of the meeting.

LAND ACKNOWLEDGEMENT STATEMENT

Chancellor Robert Jones read the Land Acknowledgement Statement.

WELCOME

Senate Executive Committee (SEC) Chair and faculty senator Jeffrey Eric Jenkins (FAA) welcomed those in attendance and invited Chancellor Robert Jones to the lectern.

CHANCELLOR'S REMARKS

Chancellor Jones began his remarks by recognizing recent global tragedies, including natural disasters in Libya and Afghanistan, as well as a terrorist attack and escalating war that is unfolding in Israel that has claimed a horrific number of innocent lives. Members of the Illinois family have been directly impacted by these events, and many more are certainly struggling as they try to make sense of these tragedies. Chancellor Jones asked for a moment of silence to keep those who are grieving, all of those who have experienced loss, and those that are suffering in our hearts and our minds this afternoon.

Chancellor Jones shared notable statistics, such as welcoming the largest freshman class in University history and achieving a record undergraduate enrollment. He highlighted some of the statistics including that this new class also marks the largest number of in-state students in two decades. This indicates that the University of Illinois remains the largest provider of undergraduate education in the state which emphasizes the University's commitment to education and the state's vitality. If Illinois residents attend this University, more than 85% are going to stay here, to work here, and to raise their families here which contributes to the economic and the educational vitality of our community. Part of the commitment of a land grant University is to deliver a world class education at an affordable price. Proof is the fact that one in four freshmen are still represented by being first generation college students.

Illinois' research and our scholarly enterprise celebrated the \$30 million National Science Foundation (NSF) grant that supports the new NSF Science and Technology Center for Quantitative Cell Biology. This is a very prestigious \$30,000,000 award to create a center for Quantitative Cell Biology which will use cutting edge imaging and

simulation tools to create whole-cell models to transform our understanding of how cells really function. Illinois also received a \$13 million National Institutes of Health (NIH) grant to continue the Illinois Kids Development Study or IKIDS Program. Illinois also received about 20% of the total dollars awarded by the Department of Defense Multidisciplinary University Research Initiative (MURI). Governor Pritzker created Innovate Illinois as an effort to consolidate and aggregate the state's public and private resources to be successful in competing for federal research dollars.

Chancellor Jones announced two positions that will serve as his advisors. Cynthia Oliver, an award-winning performer and professor in the Department of Dance will take on the role of Special Adviser to the Chancellor for Arts Integration. Kelvin Droegemeier, an accomplished atmospheric scientist, and research meteorologist will serve as a Special Advisor to the Chancellor for Science Policy. Droegemeier will also provide support to President Killeen at the System level.

Chancellor Jones discussed the University's rankings and shared about his recent international travels to connect with global partners requesting collaboration with the Illinois. Jones concluded by thanking those involved in shared governance and for all the efforts in advancing the University to the next level of excellence.

Chancellor Jones welcomed President Timothy Killeen to the Lectern.

PRESIDENT'S REMARKS

President Killeen began by echoing Chancellor Jones' recognition of the devastating events across the globe. Many members of the University community are in pain. It is important to see them, hear them, and interact with them.

Killeen shared his experiences on a road tour with the three Chancellors up and down the State of Illinois visiting school districts, community colleges, legislative districts, and extension offices. The University of Illinois System is revered across the state. The group learned about equity imbalances and discovered healthcare deserts, food deserts, and educational deserts. The University needs to be the binding mechanism to create prosperity in our state in fundamental ways. There is essential work to be done to create more balance and human prosperity, which is the University's mission as supporting the public good. Killeen noted that there are high school principals that were unfamiliar with the Illinois Commitment and the Guaranteed Transfer Program for community colleges.

President Killeen also shared about the impact from MAP (Monetary Award Program) funding that has increased to assist in lessening the financial burden of higher education. The University's own financial aid is now at \$277 million which has increased by 60% over the last eight years. The University System has a record undergraduate population. About 80% of them come from the State of Illinois and they deserve access to an affordable world-class education that will propel them into civic contributions.

Research has also grown to all-time highs and the Illinois System is growing in international collaboration. There is a need to recommit to intellectual globalization, and this is the time for the University System to do that at scale. For example, Killeen traveled to Brazil where a new initiative with Illinois will focus on climate and sustainability in the Amazon region, and a focus on health and medicine to increase life expectancy. The University of Illinois System will host the International Congress on Sustainable Research and Innovation in Chicago.

OPEN DISCUSSION

Andrew Belmont (Cell & Developmental Biology) mentioned rankings and asked if there was a metric used to see if strategic planning is effective in changing the University's ranking. Chancellor Jones clarified that the University does not do top-down planning. A bold initiative is framed and then hundreds of faculty members and staff are engaged with what the strategic plan will look like. That was done with The Next 150 which builds on the next plan, Boldly Illinois. Chancellor Jones reiterated that the University does not chase ratings and strives for excellence.

Charles Roseman (Evolution, Ecology & Behavior) expressed concern about admitting students into inadequate housing. There are many undergraduate housing units that do not have air conditioning. Chancellor Jones noted the aggressive and systematic plan by Student Affairs to ensure this challenge is remedied and replied that there are currently no plans to adjust enrollment.

Dave Beck (History) expressed concern about Native American students, alumni, and faculty members that they felt they were in a hostile environment because of continued use of the previous mascot. Beck also requested implementing a new mascot as a way forward. Chancellor Jones shared that the legal issue of the previous Native American image is complex and cautioned that there is no simple solution other than time and effort in staying on task. The University went from Critical Conversations to convening a task force to now implementing a working group that is looking at creating new traditions that may or may not include a mascot.

CLOSING

The Annual Meeting of the Faculty concluded at 4:10 pm.

VI. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

SEC Chair Jenkins noted the continued efforts to manage greater accessibility for those who need accommodations to attend Senate meetings. Jenkins noted that efforts will be made to continue working with the state legislature towards a solution that will allow for online participation. Following a robust discussion with the Chair of the Senate Committee on University Student Life (SL), the SEC asked for more information before considering a proposal for a possible fall holiday. The research policy sub-group continues meeting and engaging with a process of building faculty consultation with the Office of the Vice Chancellor for Research and Innovation.

There are also several system level documents that have been sent with requests for feedback. These include OT-372 which is a document on the development of system policies which SEC referred to the Senate Committee on General University Policy (GP) and that feedback has been forwarded to the system. Another item, OT-387, focuses on system values and principles for conduct. This matter has been referred to GP and the Senate Committee on Academic Freedom and Tenure (AF). Each committee will produce feedback that will likely warrant a full Senate conversation before it is submitted to the system. Finally, there is OT-385 which is a document about understanding FOIA (Freedom of Information Act) and how it affects members of the University community.

As these challenging times continue, please be aware of the many student, faculty, and staff resources that are available to help care for yourself and others, especially those affected by recent world events.
