The Department of Urban and Regional Planning (DURP) are requesting an elimination of this program.

Why are these changes necessary?

The Master of Science in Sustainable Urban Management program (MSSUM) has not generated enough students to either justify the resources spent on it or create dedicated courses and the kinds of cohort learning from them.

The program initially had a goal of admitting 10 students per year. Mid-career students were unable to relocate for a one-year period. The market for the program was quite limited. Exit interviews were conducted and the department learned that students attended when they had an institutional agreement, via their current employer, to cover the program and the costs of relocation, or when somebody already in the Champaign-Urbana area had a single year to spare. Both of these populations can be served with the Master of Urban Planning program.

The 32-hour program has 4 required courses, 4 credit hours each (UP 504, 505, 512, 513). Two of those courses (8 hours-UP 512 and 513) have not been offered since spring of 2019 due to never having enough students to warrant. Course substitutions were regularly utilized. Therefore, students in the MSSUM have been completing an amended program which mirrors the MUP (Master of Urban Planning) program, with less total credit hours. The program learning outcomes were delivered through substitute courses, but the program ultimately was not offered as designed. UP 512 and UP 513 will be deactivated.

The two other required courses are also required in the MUP program (UP 504 and UP 505) and, therefore, there is no impact to the unit course offerings or faculty teaching assignments as a result of this program elimination. The remaining credit hours of the 32-hour program were elective hours.

DURP faculty initially discussed a temporary suspension of admission to the program, but ultimately voted to eliminate the MSSUM program on September 18, 2024 with a faculty vote of 12 in favor and none opposed. The department head, Marc Doussard, has discussed this elimination with Senior Assistant Dean Nicole Turner, Associate Dean Greg Anderson, Associate Dean Ollie Watts Davis, and Dean Jake Pinholster and has the support of the college.

The application was open through the Graduate College for Fall 2024, with 5 students admitted. None of the students accepted their offer of admission to the MSSUM, although one student shifted their application to the Master of Urban Planning (MUP), was admitted, and is currently in that program. Therefore, there are no current students in the MSSUM program.

Two of the four required courses (UP 504 and UP 505) for the MSSUM are also required for the Master of Urban Planning in Urban Planning program and will continue to be offered as scheduled previously, with a minimally fewer amount of students but as the MUP is a larger program there is no concern over class size. The other two required courses (UP 512 and UP 513) have not been offered since 2019 and thus has no impact on faculty load and they will be deactivated. The remaining requirements are elective options.
