EP.25.106 2024-2025 Annual Report of the Senate Committee on Educational Policy

This report summarizes the activities of the Senate Committee on Educational Policy (EP) during the 2024-2025 academic year. EP held eight meetings during the fall 2024 semester (August 26, September 9, September 30, October 7, October 21, November 4, November 18, December 2) and seven meetings during the spring 2025 semester (January 27, February 3, February 24, March 3, March 24, April 14, April 21). More detailed information is provided in the minutes of those meetings.

EP received relevant updates from *ex officio* members including representatives from Associate Provost for Enrollment Management, Executive Director of the Council on Teacher Education Designee, Council of Undergraduate Deans Designee, Dean of the Graduate College Designee, Director of the Center for Innovation in Teaching and Learning, Director for General Education, Chair of the General Education Board and Provost Designee.

EP functions with three subcommittees, which take leadership of consideration of proposals referred to EP by the Office of the Provost. Each committee member serves on at least one of these subcommittees. All proposals which come to the Senate have been considered and voted on by the entire committee.
