CC.25.21 2024-2025 Annual Report of the Senate Committee on Committees

This report summarizes the activities of the Senate Committee on Committees (CC) during the 2024-2025 academic year. CC held five meetings during the fall 2024 semester (September 3, October 1, November 5, November 19, December 11) and five meetings during the spring 2025 semester (February 4, March 4, April 1, April 22, April 29). More detailed information is provided in the minutes of those meetings.

I. ITEMS APPROVED BY THE SENATE

CC.25.01, Election of the 2024-2025 Senate Executive Committee (SEC) Chair The proposal was approved by CC on 04/16/2024 and elected by the Senate on 04/29/2024.

CC.25.02, Election of the 2024-2025 Senate Executive Committee (SEC) Vice-Chair The proposal was approved by CC on 04/16/2024 and elected by the Senate on 04/29/2024.

CC.25.03, Election of the 2024-2025 Presiding Officer of the Senate

The proposal was approved by CC on 04/16/2024 and elected by the Senate on 04/29/2024.

CC.25.04, Election of Faculty Senators to the 2024-2025 Senate Committee on University Senates Conference (USC)

The proposal was approved by CC on 04/16/2024 and elected by the Senate on 04/29/2024.

CC.25.05, Election of a University Senates Conference (USC) Member to Serve on the 2024-2025 Senate Executive Committee (SEC)

CC.25.06, Election of Members to the 2024-2025 Standing Committees of the Senate and Senate Representatives to Governance, Advisory, and Other Bodies

The proposal was approved by CC on 03/21/2024 and partially elected as amended by the Senate on 04/29/2024. Due to the loss of quorum on 04/29/2024, the Senate

reconvened on 05/06/2024. However, quorum was not achieved, so the remaining slate was elected by the Senate Executive Committee on behalf of the Senate on 05/13/2024.

CC.25.07, Election of Committee Chairs to the 2024-2025 Standing Committees of the Senate

The proposal was approved by CC on 03/21/2024 and proposed to the Senate on 04/29/2024. Due to the loss of quorum on 04/29/2024, the Senate reconvened on 05/06/2024. However, quorum was not achieved, so the slate was elected by the Senate Executive Committee on behalf of the Senate on 05/13/2024.

CC.25.08, Election of Committee Chairs to the 2024-2025 Senate Executive Committee (SEC)

The proposal was approved by CC on 03/21/2024 and proposed to the Senate on 04/29/2024. Due to the loss of quorum on 04/29/2024, the Senate reconvened on 05/06/2024. However, quorum was not achieved, so the slate was elected by the Senate Executive Committee on behalf of the Senate on 05/13/2024.

CC.25.09, Faculty Nominations to the 2024-2025 Joint Advisory Committee on **Investment, Licensing, and Naming Rights**

The proposal was approved by CC on 03/21/2024 and proposed to the Senate on 04/29/2024. Due to the loss of quorum on 04/29/2024, the Senate reconvened on 05/06/2024. However, quorum was not achieved, so the slate was elected by the Senate Executive Committee on behalf of the Senate on 05/13/2024 and transmitted to the Chancellor on 08/22/2024 for appointment.
