The History + Theory + Preservation concentration (HTP) is dedicated to the important role that architecture, landscapes, and building practices play in shaping the world we live in and promotes student learning based in humanities-based disciplines of architecture history and theory, with applied practice in historic preservation. Students are eager to pursue formal study in these disciplines as pathways to study at the PhD level and as a pathway to careers in historic preservation and heritage.

The School of Architecture currently offers five graduate concentrations that focus largely on technical knowledge (Building Performance, Design of Tall Buildings, Detail and Fabrication) and social science methods (Health & Well-Being, Urbanism). It does not currently offer a concentration based in the Humanities, a core methodological framework in architecture schools around the world.

The concentration total is 16 credit hours. Two courses/7 credit hours are also requirements in the MArch degree.

Students declaring the History + Theory + Preservation concentration (HTP) Concentration are required to submit, at the end of their first semester of study and not later than the first day of classes of the second semester, a planned schedule that outlines their coursework for the next three semesters. This plan must be signed by the student and the Advisor and submitted to the Chair of HTP and the Director of Graduate Studies not later than the second week of classes in the student's second semester of study.

This Concentration can be completed within the normal time frame of the M.Arch or M.S. degree. The five courses required for the HTP concentration can overlap with the requirements for the M. Arch program. Students in the MS Architectural Studies may need to take additional courses to meet concentration requirements beyond what is required for their MS degree. Upon completion of the graduate concentration, students will submit a brief written self-assessment pertaining to history, theory, and preservation in architecture. Successful completion of the Concentration will be noted on the student's official transcript.

The concentration will be assessed yearly at the close of the Spring Semester. Assessment will take place in three formats: student assessments, course work, overall faculty review of program, and writing self-assessment.

Identify faculty expectations for students' achievement of each of the stated student learning outcomes. What score, rating, or level of expertise will signify that students have met each outcome? Provide rating rubrics as necessary.

- 1. All concentration students will have a group or individual town hall meeting as well as ask them to assess the concentration courses in writing in terms of the courses learning objectives, whether the program is meeting their expectations, meeting student goals, and the efficacy of specific courses in meeting these goals. Students will be asked to suggest areas for improvement. These student assessments will be shared with all program area faculty. These assessments will be anonymous and will be conducted by the chair of the Program Area.
- 2. Student Learning objectives will be measured using their performance in concentration course work. A report of the same will be made available to all Program Area Faculty.
- 3. Faculty of the program area will meet at the close of each Spring semester to assess the concentration, its learning objectives and the ability of students to meet these objectives based on summaries of 1 and 2 above. Faculty will suggest areas needing improvement and these will be shared with all Program Area Faculty.
- 4. Students will submit a brief 500 word written self-assessment upon completion of the graduate concentration that addresses
- a) how history, theory, and preservation has overlapped with issues related to architectural practice (focus on any one or two of the three areas is acceptable)
- b) how they foresee using history, theory, and preservation in their future work and/or career path
