EP.26.015 Report on Proposals Administratively Saved to Fix Red Boxed Courses in Program of Study Tables

In an effort to help ensure that the Academic Catalog reflects the most current course offerings and accurate information for programs in a timely manner, programs with “red box errors” – courses in the program of study table that are no longer active and exist in a choose from list, have an updated rubric or course number with no other changes, or are listed with an incorrect number of credit hours – were identified via a report from the CIM-P and vetted by the Provost’s office for eligibility for an update via Administrative Save in the CIM-P system.
