SA.25.01 2024-2025 Annual Report of the Council on Student Conduct Expectations and Accountability

This report summarizes the activities of the Council on Student Conduct Expectations and Accountability (SA) during the 2024-2025 academic year. SA held four meetings during the fall 2024 semester (September 25, October 24, November 21, December 5) and four meetings during the spring 2025 semester (February 27, March 26, April 24, May 6). More detailed information is provided in the minutes of those meetings.

SA primarily considered proposed changes to the Student Code that came from a variety of constituencies, referring to the Senate Committee on Educational Policy those proposed changes that were under its jurisdiction. The following sections of the Student Code were revised, with all changes supported by SA and forwarded to Chancellor Robert Jones for final approval. Chancellor Jones approved these revisions in June 2025, which will be published in the 2025-2026 edition of the Student Code.

## 1-302 Rules of Conduct (d)

Amends the definition of hazing to more closely align with the federal definition under the Stop Campus Hazing Act.

- § 2-302 Preamble (b)(d)(f)
- § 2-303 Requirements for Registration for Registered Organizations and Registered Student Organizations

Revises practices of the Department of Student Engagement concerning student organizations.

#### § 2-701 Basis for Chancellors Emergency Powers (a)

Clarifies conditions for imposition of interim suspension and procedures for prompt review of it.

- § 3-102 Grading System Grades Authorized for All Colleges
- § 3-103 Computation of Scholastic Averages (b)

Removes "ABS" as an option for a grade for unexcused absence from a final.

# § 3-104 Other Grade Symbols in Use (Undergraduate Students) (NC)

Removes "ABS" grade option and makes explicit when an Incomplete grade changes.

#### § 3-106 Grade Corrections

Removes reference to "ABS" grade.

## § 3-201 Final Examinations (b)(2)

Revises policies on synchronous finals and exam conflicts.

## § 3-203 Proficiency Examinations (a)(4)(A)

## § 3-204 Special Examinations (b)(1)

Adds reference to the end date of "ABS" grades.

## § 3-301 Number of Hours Required (a)(3)

Replaces text definition with a chart outlining full-time/part-time status and revises definition of graduate student full-time enrollment.

# § 3-307 Late Registration (a)(1-5) (b)

Eliminate the late registration fee.

## § 3-404 University Honors – Bronze Tablet (a)(b)(d)

Revises Bronze Tablet criteria for transfer students; removes stated physical location of Bronze Tablet; removes reference to October graduation.

#### § 3-505 Fee Assessments (h)(2)(i)

Eliminates Collegiate Readership Fee; adds reference to fee for students in degree seeking or non-degree academic credit-bearing experiences not based on campus.
