The College of Fine and Applied Arts at Illinois exists to unleash creativity as a civic force. We train artists, designers, planners, performers, educators, and scholars, not only to master their craft, but to change how people live, connect, and imagine the future. FAA is committed to teaching as liberation, to advancing diversity, equity, inclusion, and belonging, not as add-ons, but as the foundation of how we learn and create. We hold ourselves accountable to our public mission, ensuring that the work of this college benefits not only our students, but also the communities we serve. We cultivate graduates who will shape not just the future of their fields, but the future of society, creative citizens ready to work, to lead, and to imagine otherwise.

The BA in Fine and Applied Arts is an online degree-completion program created for students who have previously earned college credit but have not yet completed a bachelor's degree. Enrollment is limited to transfer students and individuals seeking re-entry to the University of Illinois Urbana-Champaign; it is not open to first-year applicants or current students pursuing an intercollegiate transfer (ICT). The program is intentionally structured to expand access and reduce barriers for students seeking to complete their undergraduate education.

As a flexible and transdisciplinary online pathway, the BA in Fine and Applied Arts represents a significant addition to the academic portfolio of the College of Fine and Applied Arts and the University of Illinois Urbana-Champaign. By broadening access to a Fine and Applied Arts education, this program supports the university's land-grant mission and serves the State of Illinois by enabling individuals to build upon existing knowledge and pursue new areas of professional growth. A market research study with Eduventures is underway to identify potential concentrations or opportunities within this degree program, with the potential for development after the major is initially approved.

Students in the BA in Fine and Applied Arts will complete 3 core courses (8 hours) of orientation to transdisciplinary arts (FAA 301 - 3 hours, newly developed), professional development (FAA 310 - 2 hours, existing course but modernized content for this program), and a creative futures capstone (FAA 401 - 3 hours, newly developed). Students will then elect at least 9 hours of advanced/upper-level coursework in FAA and an additional 12 hours of coursework in FAA, which may be at any level. Additionally students must complete general education courses and other campus requirements. The program is designed with flexibility in mind and the understanding that students will be arriving to the program with a wide range of experiences and coursework. The objective of this program is to provide students with a high-quality education that includes both liberal arts and pre-professional components and prepares them for future career advancement. Graduates of the program will be poised for successful careers in industry and non-profit sectors that utilize interdisciplinary skills across the fine, environmental, and performing arts.

FAA 301 and FAA 401 are fully approved for FA 26 and documentation is attached.

The Bachelor of Arts in Fine and Applied Arts provides students with a well-rounded transdisciplinary education in fields associated with performing, environmental, and fine arts. Students take coursework in a selection of online offerings from urban and regional planning, architecture, landscape architecture, dance, music, theatre, and art and design. The remaining coursework, after completing general education courses, is comprised of free electives, to allow for maximum flexibility for students. The program is offered online, and students take online coursework to complete degree requirements.

Evaluation of student learning in the BA in Fine and Applied Arts will accord with the guidelines and procedures established by the campus Council on Learning Outcomes Assessment. It will include review of samples of student work for all courses in the major by the faculty director of the program and a biennial review of syllabi for these courses by the College Courses & Curriculum committee.

The BAA in FAA administration will use key performance indicators to evaluate the program annually. The key performance indicators include:

- number of applications received
- enrollment figures disaggregated
- course evaluations
- time to degree completion
- student performance metrics (course grades, GPA, etc)
- Campus Illini Success Survey providing the college with data about students' first destinations after graduation

To maintain academic standards, each student is required to uphold a minimum GPA of 2.0 per semester to avoid placement on academic warning. Furthermore, students must not remain on academic warning for more than two consecutive semesters to prevent consideration for dismissal from the program. Any student who attains a GPA below 1.0 during a semester faces dismissal. Additionally, a minimum cumulative GPA of 2.0 is necessary for graduation. Advisors are crucial in monitoring student performance and progress and providing personalized mentoring and support.

To ensure students achieve learning outcomes, faculty will monitor student progress through various assessments aligned with each course's specific goals. Faculty will utilize rubrics to clearly define student expectations. Faculty can also collaborate with instructional designers to guarantee their assessments accurately measure learning outcomes.

The faculty director of the program will meet annually with faculty who teach courses that are part of the major to review learning objectives and, where necessary, to make recommendations to enhance student learning.

Additionally, the faculty advisor will monitor individual students' academic performance. They will notify, engage, and support students who land on academic warning. The Faculty director will work with a college committee to conduct regular program reviews, incorporating assessment data alongside faculty and student feedback. They will identify any specific areas to enhance student learning. This could involve gaps in particular skills, knowledge areas, or learning outcomes.

This proposal maximizes the currently available resources and course seats in the College of Fine and Applied Arts. FAA 301 will be taught by a staff member in the FAA Undergraduate Affairs office who currently teaches FAA 101 and will be compensated a one-time SIE for the development of the online course and instruct the course in future semesters as part of their position. FAA 310 will be taught by a staff member in the FAA Undergraduate Affairs/Academic Programs office, who will be compensated a one-time SIE for the development of the online course and instruct the course in future semesters as part of their position. An admin or faculty director for the degree will develop FAA 401, build the website and marketing materials, direct the program, and advise the students. This will occur as either a course release or a stipend. The flexibility of the remaining online courses in FAA and across campus allow for open seats to be utilized in current online courses. As the program grows, the director may coordinate for specific seat requests in popular courses for the BA in FAA students.

Students in the BA in Fine and Applied Arts will enroll in courses that are also offered to students in the departments' residential undergraduate majors, but the focus of the BA FAA will offer a broad, cross-college interdisciplinary education in arts-related fields. Accordingly, the BA in FAA is a distinct degree and will provide a unique education different from those programs already available in the College of Fine and Applied Arts.

The proposal for the BA in Fine and Applied Arts is jointly sponsored by all FAA departments involved. The creation of the program was discussed by a workgroup with representatives from all units in FAA and approved by the Unit Executive Officers of all 7 units (Music, Dance, Theatre, Art & Design, Urban and Regional Planning, Architecture, and Landscape Architecture), as well as the FAA college curriculum committee, and Dean of the College.

# **University of Illinois**

The University of Illinois Urbana-Champaign seeks to transform lives through education. The proposed BA in Fine and Applied Arts aligns with this goal by offering an opportunity to complete an innovative, transdisciplinary college degree at the University of Illinois Urbana-Champaign for a group of learners who otherwise may not have been able to do so due to geographic, financial, and other barriers.

There is high demand for prospective employees equipped with the skills and knowledge gained from the BA in FAA, such as developing aesthetically driven concepts, collaborating in the vision and design process, leading interdisciplinary teams, and assessing spaces that convey messages to an audience.

The transdisciplinary training education offered through the BA in Fine and Applied Arts prepares students for careers which the Illinois Department of Employment Security has designated as growth areas within these fields--Art directors, Designers and various management positions [IDES Long-Term Occupational Projections 2022-2032). North American Industrial Classification System (NAICS) categories for Arts, Entertainment and Recreation; Performing Arts, Sports & Related Industries; Museums, Historical Sites & Institutions all have positive long-term industry projections as well.

The Occupational Outlook Handbook, from the Bureau of Labor Statistics (as of 9/22/25) states the following growth projections for these careers:

Arts and Design (including art directors, craft and fine artists, set and exhibit designers, graphic designers): "About 84,900 openings are projected each year, on average, in these occupations due to the need to replace workers who leave the occupations permanently. The median annual wage for this group was \$53,180 in May 2024, which was higher than the median annual wage for all occupations of \$49,500."

Management (including architectural and engineering managers, entertainment and recreation managers, social and community service managers): "Overall employment in management occupations is projected to grow faster than the average for all occupations from 2024 to 2034. About 1.1 million openings are projected each year, on average, in these occupations due to employment growth and the need to replace workers who leave the occupations permanently. The median annual wage for this group was \$122,090 in May 2024, which was higher than the median annual wage for all occupations of \$49,500." Within this category are Entertainment and Recreation Managers, which is projected to grow 8% from 2024 to 2034, "much faster than average for all occupations."

By examining "field of degree" in The Occupational Outlook Handbook, from the Bureau of Labor Statistics (as of 9/22/25):

- -52% of workers in the field of Fine and performing arts (2023) were employed in an occupation requiring at least a bachelor's degree
- -60% of workers who had an interdisciplinary studies degree or a social sciences degree (2023)

Arts-related skills are increasingly valued across various sectors—including business, education, government and public policy, and non-profit organizations—and individuals working in these areas will find that earning a BA in FAA can support career advancement within their current organizations.

All students within the College of Fine and Applied Arts, including students in the BA in FAA, have access to FAA Career Services. This office sponsors events related to career exploration and preparation, as well as one-on-one appointments with a career services professional to provide students with support for their career search. These opportunities are all available both in-person and virtually, which will allow full access to resources for students in this online degree program.

Additionally, two of the required courses in this program (FAA 310 Professional Development and FAA 401 Creative Futures) will support students with taking the necessary step to work toward their career goals.

All UIUC students have access to the job search platform, Handshake.

**Comparable Programs in Illinois**

There are no comparable programs in the State of Illinois (online, specific to fine and applied arts and not general liberal arts education).

Two programs are similar, but in-person: University of Illinois Chicago BA in Interdisciplinary Education in the Arts in the School of Art and Art History; Northeastern IL University Bachelor of Arts in Interdisciplinary Studies (BAIS), concentration in Fine Arts. For students who are unable to access these institutions and frequently attending in-person classes in or near downtown Chicago, their needs are unmet.

10 institutions across the state offer fully online Liberal Arts and Sciences/Liberal Studies degrees, and 6 are public universities (Chicago State, Eastern Illinois, Governors State, Southern Illinois Carbondale, University of Illinois Springfield, and Western Illinois).

Based on analysis of available options in the state of Illinois, it appears that the addition of the BA in FAA will be complementary to existing offerings, and there will be no negative impacts on these programs. The University of Illinois Urbana-Champaign College of Fine and Applied Arts is situated to offer a unique opportunity for degree completion for students with a background in or future interest in studying the fine and applied arts online.

Phase 1 from Eduventures Research market study indicated that few direct competitors exist, nationally, due to the program being interdisciplinary and arts-affiliated. Phase 2 of the study will look further at the closest peer programs (Arizona State Interdisciplinary Arts and Performance and University of Arizona BA/BS in Interdisciplinary Studies, concentration in Arts/Media/Entertainment).

**Equity-Centered Program Design** 

The BA in FAA program is built with a strong commitment to equity, aiming to reduce barriers and support a diverse student population. This mission will be realized through several key initiatives:

### Accessibility and Affordability

Offered fully online, the program removes geographical constraints and accommodates the schedules of working adults seeking to complete their undergraduate degree. With a competitive per-credit-hour tuition rate, the program is designed to be financially accessible. Traditional residential programs often pose financial and logistical challenges—such as relocation costs, campus fees, and income loss—which can deter students for whom such a format is not feasible. This program eliminates those barriers.

### **Targeted Outreach and Personalized Support**

We will actively engage prospective students through partnerships with community colleges and organizations serving diverse populations. A dedicated faculty advisor and admissions team will offer personalized support throughout the enrollment process, ensuring a smooth and welcoming transition.

#### Inclusive Curriculum and Marketing

The program's curriculum is designed to accommodate a wide range of learners' cultural perspectives and experiences. Marketing materials will highlight the program's commitment to inclusivity and its value for students of all backgrounds.

#### **Comprehensive Student Support Services**

From assistance with registration to access to academic resources, students will receive the tools they need to thrive.

#### Flexible Learning for a Diverse Student Body

The BA in FAA is a strong fit for students eligible for the UI System Transfer Guarantee Program. By providing an entirely online degree option, students can earn a University of Illinois education without relocating, contributing to geographic and demographic diversity. Whether from urban or rural areas, students will have equitable opportunities to complete their degree.

The program also supports the university's land-grant mission by expanding access to higher education for underserved communities across Illinois. Designed specifically for working adults, it helps overcome financial barriers by allowing students to remain employed while completing coursework. Asynchronous courses and flexible scheduling will allow students to balance

academic, work, and personal responsibilities.

This increased accessibility helps close the achievement gap for low-income, minority, and first-generation students. Expanding degree completion not only benefits individual students but also strengthens the communities they serve.

Flexible Enrollment and Strategic Partnerships

Unlike residential students, participants in the BA in FAA program are not required to enroll full-time. The program aligns with existing University of Illinois transfer pathway initiatives, and the College of FAA is committed to building strong relationships with community colleges across the state. By tracking the educational backgrounds of enrolled students, the College will evaluate and refine outreach efforts to ensure inclusive recruitment. These strategic partnerships will help reach students who may not have previously seen the University of Illinois as an accessible or realistic option.

Describe program and institution-based high-impact practices and wrap-around student support services ensuring equitable access and success for students enrolled in the proposed program.

The University of Illinois College of Fine and Applied Arts recognizes a broad and inclusive concept of diversity as a springboard toward mutual understanding. Diversity encompasses complex differences and similarities in identities and perspectives among members of our college, as well as among individuals who make up the broader global community.

The College of Fine and Applied Arts leadership team includes an Associate Dean for Diversity, Equity, and Inclusion. This leadership role connects the college to campus diversity efforts through the Office of the Vice Chancellor for Diversity, Equity, and Inclusion (OVCDEI). This presence of the Associate Dean also demonstrates a commitment to diversity within the College of FAA. The Associate Dean, working together with the College of FAA Diversity, Equity, Inclusion, and Access Committee, consisting of faculty, staff, and student representatives, also coordinates diversity-focused training and workshops for members of the College of FAA community. Many of these events are offered hybrid or virtual and will continue to do so.

The FAA Undergraduate Affairs Office includes four staff members focused on student services: the Associate Dean for Undergraduate Academic Affairs and the Assistant Director of Student Engagement and Academic Success. These staff members closely monitor and provide support for all students who are reported as not engaging in classes, have extenuating circumstances impact their academic success, or who are on academic probation. An embedded mental health counselor is available for virtual sessions for FAA students and who offers virtual drop-in hours each week. Additionally, FAA Career Services offers virtual workshops and online appointments to support the professional development and goals of all FAA students.

Two staff in the FAA Undergraduate Admissions Office will coordinate the recruiting, admissions, and applications for the BA in FAA.

The faculty director appointed for the BA in FAA will be the primary point-person offering Explain institutional strategies being implemented to increase and retain faculty, staff, and administrators of color and advising, coordination, and support for all of the BA in FAA students. the implications for the proposed program. Explain how progress will be monitored.

The College of FAA has launched a number of projects and initiatives to advance diversity, As an online program, students will be oriented through FAA 301 which will include an inclusion, equity, and access while recognizing the deep and rich work and visions offered by overview of Student Technology and resources, such as the Technology Resource Guide, our artists, designers, performers, scholars, architects, and activists. utilization of Canvas, University email, and virtual library resources.

A Post-Doctoral/Post-Graduate Fellow in the area of contemporary Black Arts has been hired By providing the BA in FAA students with a clearly communicated support team, the program and will begin in January 2026. intends to help students achieve their goal of earning an undergraduate degree and move

toward their next step of professional success. The College of FAA has continued to take steps for affirming the role of public engagement as a form of scholarly work, recognizing the importance of such work for the research, teaching, and service of historically underrepresented faculty members.

#### Sustainability

> The College of FAA shares the commitment of the University of Illinois Urbana-Champaign and the University of Illinois System to access and affordability. The College awards over \$1.3 million a year in undergraduate scholarships to new and returning students.

> This program has elected to offer the program at the base online degree completion rate, with no request for a differential level.

The College of FAA proposes a rate of \$433 per credit hour for students in the BA in Media degree program. This is the current campus base rate for per-credit hour online degree tuition and is in line with other online undergraduate programs at the University of Illinois Urbana-Champaign, including the Bachelor of Liberal Studies degree completion program in the College of Liberal Arts and Sciences (\$433 per credit hour), the BA in the College of Media (\$433 per credit hour), and the iBSW program in the School of Social Work (\$490 per credit hour).

The program will develop a clear and comprehensive online resource that outlines the costs associated with the BA in FAA program to empower students to make informed financial decisions. Students will be eligible to apply for financial aid through the University.

#### Growth

Strategic National Arts Alumni Project (SNAAP) survey data (over 50,000 people who are over 30 and have ever worked in an arts-related occupation) broadly shows that arts students place a high value on the liberal arts aspects of their education, but also want to integrate entrepreneurial, business, and financial preparation while in school. "our research reveals a new class of arts school graduates: 'the generalists'. SNAAP survey data have long confirmed the intuition that double majors combining a major in the arts with one outside the arts are less likely to stay in the arts as a career, compared to respondents with only a single arts major. However, much less intuitively, compared to arts-based workers who are more prone to specialization, graduates who expand the number of artistic occupations in which they have worked (what we call 'generalists') are much more likely to stay in the arts."

Explain how the program engaged with business and industry in its development and how it will spur the state's economy by leveraging partnerships with local, regional, and state industry, business leaders and employers.

The BA in FAA was developed with an eye toward meeting the needs of the state for workers seeking to complete their undergraduate degree in the areas of fine, performance, and environmental arts. This may lend graduates the ability to advance further in their current career or to shift to a career in an area of interest.

The College of FAA Office of Advancement connects regularly with alumni who actively contribute to College programming and resources related to career development, networking and mentoring. Once approved, the College plans to explore partnerships with the Office of Corporate Relations and the OVCRI, which can help connect the program, as well as its students and alumni, with opportunities.

Describe how the proposed program will expand access and opportunities for students through high-impact practices including research opportunities, internships, apprenticeships, career pathways, and other field experiences.

As an online program, the BA in FAA is well-positioned to take advantage of students' increased familiarity with remote learning and work, a shift accelerated by the COVID-19 pandemic. The College expects that many students will continue to work, possibly full-time, while completing their degree. To support this, the program intends to integrate students' professional experiences into opportunities for industry engagement, research, and internships tailored to their individual circumstances. The curriculum begins with FAA 301, a course for academic and professional goal setting, includes FAA 310 focused on professional career preparation, and culminates in a creative careers capstone course (FAA 401), which allows students to apply their accumulated knowledge—whether from coursework, independent study, or virtual internships—to explore contemporary issues in the fine and applied arts landscape. Students are eligible to enroll in internship credit, which is supervised by unit faculty and contains academic coursework along with, as part of their FAA upper-level coursework (ex: MUS 459 Internship, ARTD 399 Design Internship, FAA 493 Practical Engagement Opportunity, FAA 497 Crip\* Research Internship, UP 390 Planning Internship).

Explain how the proposed program will expand its models of teaching and learning, research, and/or public service and outreach that provide opportunity for students to succeed in the work of the future.

The College of FAA has worked closely with the Center for Innovation in Teaching & Learning to develop high-quality, online courses including FAA 201 Black Arts Today and FAA 102 Design Beyond Boundaries (online and asynchronous), required graduate online courses for the online MS in Architectural Studies program, and large general education courses which are offered both in-person and online, such as THEA 110 Broadway Musicals. Departments which may not be assumed to offer online content have worked diligently to develop innovative, online approaches to learning (DANC 100 Intro to Contemporary Dance which has students take an online dance class or tutorial, provide creative responses like a video scavenger hunt and submission of an online dance video, and is targeted for non-dance majors).

Many FAA faculty members have participated in additional summer training to enhance course delivery through the Canvas system. Meanwhile, the College of FAA is actively working to optimize all courses to comply with Title II accessibility standards, supporting a universal design approach. The e-Learning librarian at UIUC has provided materials to educate online learners in degree-completion programs on library services and resources, which will be provided through FAA 301.

Beyond workforce need, describe how the program broadly addresses societal needs (e.g., cultural or liberal arts contribution, lifelong learning of Illinois residents, or civic participation).

A transdisciplinary arts degree cultivates creative expression, critical inquiry, and cross-cultural understanding. The degree emphasizes adaptable skills—such as creativity, communication, collaboration, and problem-solving—that support continued personal and professional growth. This adaptability strengthens the state's workforce and promotes ongoing engagement with learning.

Second, individuals who began but did not complete a four-year degree often face obstacles in career advancement while still managing the burden of student debt. An online degree completion program like the BA in FAA provides a flexible pathway to finish their education without disrupting work or family commitments.

The Bachelor of Arts in Fine and Applied Arts provides students with a well-rounded transdisciplinary education in fields associated with performing, environmental, and fine arts. Students take coursework in a selection of online offerings from urban and regional planning, architecture, landscape architecture, dance, music, theatre, and art and design. The program is offered online, and students take online coursework to complete degree requirements.

Students are required to take the following courses: FAA 301 Interdisciplinary Arts at Illinois FAA 310 FAA Professional Development FAA 401 Creative Futures in Interdisciplinary Arts 9 hours of FAA electives at the 300 level or higher 12 hours of FAA electives at any level

Course Descriptions for Required Courses are Listed Below:

FAA 301 Interdisciplinary Arts at Illinois:

This course introduces students to interdisciplinary arts while providing an advanced orientation to online learning at UIUC and within the College of Fine and Applied Arts (FAA). Students will explore and refine their personal and professional interests, design an intentional educational pathway, and strengthen skills in time management, goal setting, and professional communication. Emphasis is placed on cultivating ethical and culturally informed perspectives, connecting prior experiences to academic growth, and preparing for future career aspirations in the arts and beyond.

FAA 310 Professional Development: Focuses on tailoring written, verbal, and online presentations to targeted audiences. Students will develop an application package including resume, letter, LinkedIn profile, elevator pitch, interview skills, and website.

FAA 401 Creative Futures in Interdisciplinary Arts: This course empowers students to curate a final project or portfolio of their experiences, skills, and knowledge in preparation for careers in interdisciplinary artistic practice. Students will examine industries and projects of interest and cultivate a plan for their career. It is the culminating course in the BA in FAA degree program.

Students in the BA in FAA are required to earn a total of 120 credit hours, including general education requirements, the university's residency requirement of 45 hours of UIUC coursework of which 21 hours are 300- or 400-level courses and a minimum of 40 hours total of upper division coursework.

There are 8 hours of required core courses and 21 hours of required major electives, for a total of 29 degree hours.

All courses counting toward major or general education requirements must be taken for a letter grade.

The College of FAA will appoint an admin or faculty member with course release or stipend to serve as the program director, coordinator, and advisor. They will serve as the point person and academic advisor for students in the BA in FAA. They will support onboarding of new students, aid them in the selection of courses, ensure that they are making adequate progress toward the degree, and, where appropriate, connect them with campus resources. Students will also have access to FAA Career Services, including group programming and one-on-one appointments, both of which are available in online/virtual formats.

Are the unit's current facilities adequate to support the program when fully implemented? Will there need to be facility renovation or new construction to house the program?

Classes in this program will be offered entirely online, so physical classroom spaces are not necessary. Faculty will utilize existing production and studio spaces and with the Center for Innovation in Teaching & Learning (CITL) to develop and revise their online courses.

Librarians from the Ricker Library of Architecture & Art (Emilee Mathews, subject librarian for Art, Architecture, Design), Funk ACES Library (Michael Dickinson, subject librarian for Landscape Architecture, Planning), Music and Performing Arts Library (Kate Lambaria, subject librarian for Dance, Music, Theatre), and e-Learning (Evie Cordell) were consulted on September 22, 2025. College of FAA leadership confirmed that impact on the Library will be minimal given the nature and size of the program. Each of the librarians indicated that it would be straightforward to meet the needs of students in the BA in FAA program since they will be enrolled in courses that the Library already supports and because the three associated libraries already offers robust virtual support services. Additionally, the e-Learning librarian has already prepared resources and services to be integrated into courses for fully online degree programs.

Most courses within the BA in FAA will not require standard textbooks.

The BA in FAA program will be developed and maintained by current faculty and staff. The program will be jointly administered by the College's academic departments and schools via a faculty director/coordinator/advisor to be selected from among the current faculty; the college-level Courses and Curriculum committee, and, as ex officio, the Associate Dean for Academic Programs and International Education.

Faculty instructors in the program come from the College of FAA's tenure-stream and specialized faculty. Tenure-stream faculty who will teach in the BA in FAA have terminal degrees and are renowned experts in the field with dedication to classroom teaching. Specialized faculty generally have master's degrees and a number of years of applied experience in the field. The departments of the College of FAA take quality teaching very seriously and provide ongoing mentoring and assessments of instruction, including in annual reviews and in evaluations for promotion.

Student support services will be provided by members of the College of FAA's Undergraduate Affairs Office. These staff have master's degrees in fields related to student personnel administration or FAA-related fields and many years of experience in working with students.

Before her current role, she served for eight years as the School's Associate Director and Director of Undergraduate Studies, and prior to that, she led the University Bands program within the School of Music. She was also a 2020-21 Fellow in the Big Ten Academic Alliance Academic Leadership Program. Moorhouse earned a Doctor of Musical Arts in Instrumental Conducting from the University of Washington in Seattle, where she studied with Peter Erös and Timothy Salzman. She holds a Master of Music Education degree from Louisiana State University, and a Bachelor of Music Education with Honors from the University of Florida, where she is a member of the University of Florida Bands Hall of Fame.

Kirsten Pullen, Professor of Theatre Studies holds a PhD and an MA in Theatre Research from the University of Wisconsin-Madison. She is a performance historian with particular emphasis on female performers and performance theory in the 20th–21st century United States. She is a prolific conference presenter and has been active in the American Society for Theatre Research, serving as a member of its Executive Committee from 2011–2014.

Profesor Rebecca Nettl-Fiol has a long history with Dance at Illinois, from an undergraduate student in the 1970s, to a part time faculty member in the early 1980s, to her current position as Professor. She served as Interim Head of the Dance Department from 2001-2005, Acting Head in 1998 and 2016, was BFA Program Director from 1991-2001, and BFA co-director from 2012-2022. She received her MA in Dance and Choreography from The Ohio State University.

Assistant Professor Magdalena Novoa received her Ph.D. from the University of Texas at Austin. She also holds a M.A. in Arts and Cultural Management from the London School of Communication, a B.A. in Fine Arts from Pontificia Universidad Católica de Chile, and a B.A. in Education from Universidad Gabriela Mistral. Novoa is Assistant Professor of Urban and Regional Planning and her work focuses on the intersections of historic preservation and social justice, the politics of cultural heritage and memory, gender and deindustrialization, grassroots organizing and alternative planning approaches in the Americas.

Melissa Pokorny is a professor in the Studio Program at the University of Illinois, Urbana-Champaign, where she also serves as the Executive Associate Director of the School of Art and Design. Pokorny received her BFA in Ceramics, with a minor in Fibers from Southern Illinois University at Edwardsville, and an MFA in Studio Art from the University of California at Davis. She has received multiple awards and residencies, including a 2022 Illinois Arts Council Fellowship; the University of Illinois Program For Research in the Humanities Ragdale Residential Creative Fellowship; a 2007 Illinois Arts Council Fellowship; multiple professional project support grants from the Illinois Arts Council; and the Efroymson Arts Fellowship. Residencies include the Skaftfell Arts Center in Seydisfjordur, Iceland; The Ucross Foundation in Ucross, Wyoming; and the Ragdale Foundation in Lake Forest, IL.

Professor Lynne Dearborn, a licensed architect and NCARB certificate holder, uses her design insights to study the transactional relationships between people and their environments, particularly the multi-scalar connections among residents, dwelling environments, and cultural change. Dearborn earned her Ph.D. in Architecture from the University of Wisconsin Milwaukee, MArch from the University of Oregon, and BArch and BS from Rensselaer Polytechnic Institute.

Brenton H. and Jean B. Wadsworth Head and Professor in the Department of Landscape Architecture, David L. Hays earned his MArch from Princeton, MA and M.Phil from Yale University, A.B. from Harvard University, and has been a visiting scholar at the University of

Cambridge Department of Mictory of Art. In addition to his research and teaching he is Co

Joseph Altshuler is Assistant Professor in the Illinois School of Architecture, affiliated faculty in the Department of Landscape Architecture, and cofounder of Could Be Design, an award-winning Chicago-based design practice. His teaching, practice, and scholarship explore architecture's capacity to build lively audiences, initiate serious play, and amplify participation in civic life. Joseph's teaching and community-engaged curricula was recognized by the Association of Collegiate Schools of Architecture (ACSA) Architectural Education Awards – 2024 Creative Achievement Award. He earned his MArch from Rice University and BS in Architectural Studies from UIUC.

Associate Professor and Associate Head in the School of Landscape Architecture, Stephen Sears teaches studios ranging from foundation site design to advanced-level urban design, techniques in digital representation, and seminars about theory, practice, culture, and media.
