MINUTES

**1. CALL TO ORDER**

A regular meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:12 pm by Rurik Tywoniw serving as the Presiding Officer of the Senate with Professor Emeritus William J. Maher serving as Parliamentarian.

**2. APPROVAL OF REMOTE PARTICIPATION**

Remote participation was approved by unanimous consent.

**5. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS**

Faculty senator (ACES) and Chair of the Senate Executive Committee (SEC), Angela Lyons opened the meeting by addressing concerns regarding a recent social media post by the Illini College Republicans, a registered student organization, which featured an AI-generated image resembling imagery associated with the Iowa shooting in Minnesota. The Chair stated that the imagery was reprehensible and emphasized that hate and intolerance are not aligned with the values of the Senate or the institution. While noting that free speech is protected, the Chair stated that such actions are not condoned and that the matter is being reviewed through established University processes, including an investigation by the Title VI Office and other campus offices.

The Chair then highlighted the work of the Senate Committee on Student Conduct Expectations and Accountability (SA), noting its role in overseeing the University's student conduct framework and providing advice on related policies. Recent SA efforts include work on bronze tablet hour requirements, exam and course delivery policies, and the sexual misconduct policy. Chair Lyons thanked SA chair Chris Schmitz and committee members for their service.

Chair Lyons also provided context for upcoming votes to fill several committee vacancies resulting from the departure of a faculty member, noting nominations for leadership and membership roles on the Senate Committee on University Statutes and Senate Procedures (SP) and the Senate Executive Committee (SEC).

Finally, Chair Lyons reminded senators to discuss proposed revisions to the Policy on Integrity in Scholarly Activities (SC.26.09) with their units and submit feedback by February 23, 2026 and noted that the deadline for Senate committees to submit feedback to the Senate Review Commission (SR9) had been extended to March 16, 2026. Chair Lyons also clarified the process for considering resolutions before the Senate. Concluding the remarks, Chair Lyons introduced the use of a short five-slide briefing deck to help senators communicate key agenda items with their units and encourage engagement.

## 6. PROPOSALS

### a) **CC.26.24, Election of Members on Standing Committees of the Senate at the February 9, 2026 Senate Meeting**

On behalf of the Senate Committee on Committees (CC), Chair Chaya Sandler presented and moved approval of CC.26.24 to fill current committee vacancies. Sandler explained that CC.26.24 only lists committees with current vacancies. She noted that CC is responsible for preparing nomination slates for Senate committees based on volunteers and continuing members, and for carefully reviewing slates to ensure balanced representation across colleges, disciplines, ranks, and other perspectives. Sandler also noted that CC is exploring ways for nominees to better articulate their interest and qualifications for committee service. She reminded senators that CC meetings are open and encouraged senators to reach out with questions about the nomination process.

Presiding Officer Tywoniw called for nominations from the floor. Student senator Holt (ACES) nominated Rylee Graves (LAS) to fill the student vacancy on the Senate Committee on Diversity, Equity, and Inclusion (EQ). Graves verbally accepted the nomination. There were no additional nominations from the floor and nominations were declared closed.

By a show of hands and Poll Everywhere vote, the motion to adopt CC.26.24 as presented, including the floor nomination, was approved with 173 in favor, 0 opposed, and 3 abstentions.

### b) **CC.26.25, Election of a Committee Chair to the 2025-2026 Senate Committee on University Statutes and Senate Procedures**

On behalf of CC, Chair Sandler presented and moved approval of CC.26.25.

Presiding Officer Tywoniw called for nominations from the floor. There were no nominations from the floor and nominations were declared closed.

By a show of hands and Poll Everywhere vote, the motion to adopt CC.26.25 as presented was approved with 181 in favor, 0 opposed, and 2 abstentions.

**c) CC.26.26, Election of a Replacement Representative to the 2025-2026 Senate Executive Committee for the Chair of the Senate Committee on University Statutes and Senate Procedures**

On behalf of CC, Chair Sandler presented and moved approval of CC.26.26. Sandler noted that although Gilmore had been elected to serve as chair of the Senate Committee on University Statutes and Senate Procedures (SP) for the remainder of the term, he could not simultaneously hold a second seat on the Senate Executive Committee (SEC). Accordingly, CC.26.26 elects SP member Trei to serve as the SP representative on SEC for the remainder of the term.

Presiding Officer Tywoniw called for nominations from the floor. He noted any nominees must be members of SP. There were no nominations from the floor and nominations were declared closed.

By a show of hands and Poll Everywhere vote, the motion to adopt CC.26.26 as presented was approved with 183 in favor, 0 opposed, and 3 abstentions.

**d) SC.26.14, Election of an Undergraduate Student Senator and a Graduate Student Senator to Fill Vacancies on the 2025-2026 Committee on Committees**

On behalf of SEC, Chair Lyons presented and moved approval of SC.26.14.

Presiding Officer Tywoniw called for nominations from the floor. He noted that any nominations from the floor must be student senators. There were no nominations from the floor and nominations were declared closed.

By a show of hands and Poll Everywhere vote, the motion to adopt SC.26.14 as presented was approved with 178 in favor, 0 opposed, and 1 abstention.

**e) SP.25.05, Proposed Revision to the *Statutes*, Article XIII, Section 8 – Amendments**

On behalf of the Senate Committee on University Statutes and Senate Procedures (SP), Chair Gilmore presented SP.25.05 for a first reading. The proposal reorganizes and clarifies

existing statutory provisions governing the process for initiating and considering amendments to the University of Illinois *Statutes*. The revision largely maintains current language but streamlines the structure, clarifies responsibilities of the initiating bodies, and makes explicit certain procedural elements, including required transmittal materials and the process when the Senates do not agree or when the Board of Trustees acts contrary to Senate advice.

No discussion. As a first reading, no vote was taken.

**f) SP.26.07, Proposed Revision to the *Constitution*, Article II, Section 1.b – Faculty Representation**

On behalf of SP, Chair Gilmore presented SP.26.07 for a first reading. The proposed constitutional revision, recommended by the Senate Committee on Elections and Credentials (EC), would remove language restricting members of the faculty electorate from pursuing a degree at the University. Gilmore noted that existing constitutional provisions already prevent dual membership in electorates, making the restriction unnecessary. As a constitutional amendment, the proposal requires two Senate readings and approval by the Board of Trustees.

No discussion. As a first reading, no vote was taken.

**g) SP.26.10, Revision to *Standing Rule 15* - Use of Electronic Clickers in the Senate**

On behalf of SP, Chair Gilmore presented and moved approval of SP.26.10. The proposal makes a minor revision to *Standing Rule 15* by replacing the phrase “electronic clickers” with “electronic means” to reflect current voting practices and provide greater flexibility. It also clarifies that a show of hands is conducted to comply with the Illinois *Open Meetings Act*.

No discussion.

By a show of hands and Poll Everywhere vote, the motion to adopt SP.26.10 as presented was approved with 179 in favor, 0 opposed, and 2 abstentions.

**h) SP.26.11, Delegate the Election of 2026-2027 Student Senators to the Student Election Board (SEB)**

On behalf of SP, Chair Gilmore presented and moved approval of SP.26.11. Chair Gilmore noted that in summer 2025, the Vice Chancellor for Student Affairs dissolved the Campus Student Election Commission (CSEC) and established the Student Election Board (SEB) to oversee student elections. Approval of this item would recognize SEB as the body conducting

the upcoming spring elections and generate a new agenda item for SP to fulfill necessary follow-up actions.

Student senator Farnham (LAS) reported that the students had worked through their concerns and were mostly satisfied with the outcomes for this year's election cycle, while acknowledging that a long-term solution would still be needed.

By a show of hands and Poll Everywhere vote, the motion to adopt SP.26.11 as presented was approved with 178 in favor, 0 opposed, and 4 abstentions.

**i) RS.26.02, Resolution in Defense of the Status of Non-U.S. Citizen Students**

Student senator and Resolution Representative Holt (ACES) introduced and moved approval of RS.26.02. The motion was seconded and discussion followed.

Discussion noted revisions from SEC review, including changing the title to *Non-Citizen Students* and updating wording to "supports the administration's continued defense." One SEC recommendation to explicitly state that the Senate endorsement was not incorporated due to the advisory nature of resolutions.

Wojtek Chodzko-Zajko, Vice Provost for Graduate Education and Dean of the Graduate College, highlighted that departments can already request deferrals for graduate students, and noted the challenges of identifying impacted students. Suggestions included granting one-year deferrals with reconsideration rather than open-ended timelines.

By a show of hands and Poll Everywhere vote, the motion to adopt RS.26.02 as presented was approved with 126 in favor, 17 opposed, and 37 abstentions.

**7. PUBLIC COMMENT**

No request received.

**8. CHANCELLOR'S REMARKS**

John Coleman, Provost and Executive Vice Chancellor for Academic Affairs provided several updates to the Senate. He reported on a recent town hall regarding the future of the Discovery Partners Institute (DPI), where campus leaders discussed the next phase of the initiative, referred to as "DPI 2.0." He noted that DPI will be organized as an institute within the Grainger College of Engineering with a dotted-line reporting relationship to the Provost, a structure similar to other campus units that serve broader University functions. Coleman emphasized that although administratively housed in Grainger, DPI is intended to serve the

entire campus and support interdisciplinary collaboration. He also noted the recent purchase of a building on Wacker Drive in Chicago to support DPI operations, which represents substantial cost savings compared with earlier plans to construct a new facility.

Provost Coleman also discussed implementation of a new Illinois law establishing requirements for how public colleges and universities respond to civil immigration enforcement activity. He noted that the University has published procedures consistent with the law, largely formalizing practices the institution had already been following. Resources and guidance for faculty, staff, and students are available through the campus website.

Addressing a recent social media post by the Illini Republicans that prompted community concern, Provost Coleman stated that the University has publicly condemned the imagery and that reports have been referred to the Title VI Office and other appropriate offices for review in accordance with established procedures. He emphasized the University's commitment to both fostering an inclusive campus environment and upholding principles of free expression and academic freedom.

Finally, Provost Coleman announced the launch of a new campus strategic planning process, Illinois Leads, which he is co-chairing with Eva Pomerantz (LAS). He noted that the initiative will seek broad input from the University community to identify key priorities and help guide the institution's future direction.

## **9. QUESTIONS FROM SENATORS**

Senators raised concerns regarding a recent social media post by the Illini Republicans that included violent imagery and language timed with a student protest. Questions focused on whether the University was investigating student disciplinary cases, whether the post constituted a threat or hate speech, and whether there is consistency in applying the Student Code across different student groups. Provost Coleman and Dean of Students Steven Bryan emphasized that the Office of Student Conflict Resolution and Title VI processes are addressing the matter, noting that the post is considered offensive but constitutes protected speech under the First Amendment.

Several senators expressed that the post was intimidating and disturbing, especially for students and community members directly referenced or impacted. Coleman acknowledged the concerns, affirmed the importance of addressing potential legal and safety implications, and described efforts to notify those potentially affected. He also highlighted existing resources for immigrant students and faculty facing legal challenges and emphasized the

University's commitment to consistency, fairness, and free expression. Senators urged clearer communication and broader consideration of who might be impacted by such incidents in the future.

Questions were also raised about other registered student organizations (RSOs) disbanded in prior years, the potential for mass communications to the campus community, and the University's response to perceived double standards in handling student speech. Coleman and Bryan clarified that RSOs are only disbanded for conduct violations, not protected speech, and that communication decisions balance effectiveness and context. The discussion concluded with emphasis on maintaining community standards, supporting affected individuals, and continuing to refine University processes to respond to these issues appropriately.
