MINUTES

1. CALL TO ORDER

A regular meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:15 pm by Rurik Tywoniw serving as the Presiding Officer of the Senate with Professor Emeritus H. George Friedman, Jr. serving as Parliamentarian.

5. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Faculty senator (ACES) and Chair of the Senate Executive Committee (SEC), Angela Lyons welcomed everyone and highlighted several agenda items. Faculty senator elections are currently underway and are taking place at the same time as the process of nominating faculty to serve on the Presidential Search Committee. Lyons noted that item SC.26.17 outlines the procedures and timelines for soliciting nominations. Faculty senators may submit virtual floor nominations during the open nomination period, which runs today through March 13, 2026. The final slate of faculty nominees will be forwarded to the University Senates Conference (USC) by April 6 for submission to the University of Illinois Board of Trustees by April 8.

Chair Lyons also called attention to EP.26.068, which proposes revisions to the criteria for the Bronze Tablet. The proposal would establish an explicit GPA (grade point average) cutoff of 4.0 for eligibility and limit the calculation of eligibility to courses taken at Illinois, excluding transfer and high school coursework. Senators were encouraged to raise any concerns regarding possible impacts of the proposed changes when the item is considered.

Chair Lyons next highlighted RS.24.01, Resolution on the Allocation of Resources to Address Impacts of Collective Bargaining Agreements. She noted that the Senate previously referred the resolution to the Senate Committee on the Budget (BG) in spring 2024. BG reviewed the proposal and returned its response to the Senate in December 2025. Both the resolution and BG's response are included with the agenda materials.

Chair Lyons announced that the Senate is partnering with the Office of the Provost to host an AI-themed event on April 15, 2026 from 8:00 to 11:00 am. The program will include a plenary session, breakout discussions, and an expo focused on topics such as teaching and learning, responsible use of AI, research integrity across the research lifecycle, and issues of equity and sustainability. She thanked the Senate Committee on Information Technology (IT) and its chair, James Quisenberry, for their leadership in planning the event.

Chair Lyons also shared information about the Mellon-funded Sawyer Seminar, At Risk U: The Past, Present, and Future of Academic Freedom. The two-year initiative examines the history of the university and encourages discussion about its present and future in relation to democracy and academic freedom. She noted several related events this spring, including an April 7, 2026 program featuring Jonathan Holloway in conversation with Chancellor Robert J. Jones and Provost John Coleman.

Finally, Chair Lyons reiterated her previous remarks encouraging senators to strengthen communication with the units they represent. She thanked those who have shared Senate

updates with their departments and mentioned facilitating additional communication and engagement.

6. PROPOSALS

a) **CC.26.28, Election of Members on Standing Committees of the Senate at the March 9, 2026 Senate Meeting**

On behalf of the Senate Committee on Committees (CC), Chair Chaya Sandler presented CC.26.28 which listed one graduate student vacancy on the Senate Council on Student Conduct Expectations and Accountability (SA).

Presiding Officer Tywoniw called for nominations from the floor. With no nominations from the floor, the item was withdrawn, and no vote was taken.

b) **EP.26.068, Revise Section 3-404 of the *Student Code*, Bronze Tablet**

On behalf of the Senate Committee on Educational Policy (EP), Chair Nolan Miller introduced and moved approval of EP.26.068. The proposal addresses challenges with the current criteria, including variability in the GPA cutoff, stress for students near the threshold, and inequities related to transfer and pre-college credit. The recommended changes would exclude transfer and pre-high school graduation coursework from the GPA calculation, require at least 30 hours of coursework earned at Illinois, and establish a fixed minimum GPA of 4.0 for eligibility rather than the current top 3%.

During discussion of EP.26.068, a senator questioned whether replacing the top 3% with a fixed 4.0 GPA might contribute to grade inflation and suggested retaining a percentile approach. Sponsors responded that the proposed change is intended to increase transparency for students, since the current percentile cutoff is not known until final calculations are completed.

Another senator questioned whether excluding transfer and pre-college coursework could advantage students entering with AP credit. Sponsors responded that residency and degree requirements remain unchanged and that the revision addresses inequities created when pre-college grades affect eligibility for the Bronze Tablet. Sponsors also noted that when more than 3% of students have a 4.0 GPA, all currently receive the designation.

By a show of hands and Poll Everywhere vote, the motion to adopt EP.26.068 as presented was approved with 130 in favor, 19 opposed, and 8 abstentions.

c) SC.26.17, Determine the Procedures and Timeline for Soliciting Faculty Nominations for Service on the 2026 Search Committee to Assist in the Selection of a President

On behalf of SEC, Chair Lyons presented and moved approval of SC.26.17. Lyons noted that the item had been prepared by the Office of the Senate and approved by the SEC the previous Monday. The item outlines the timeline and process for preparing a slate of faculty nominations for service on the Presidential Search Committee. No questions were raised.

By a show of hands and Poll Everywhere vote, the motion to adopt SC.26.17 as presented was approved with 158 in favor, 1 opposed, and 5 abstentions.

d) SP.25.05, Proposed Revision to the *Statutes*, Article XIII, Section 8 – Amendments

On behalf of the Senate Committee on University Statutes and Senate Procedures (SP), Chair Gilmore presented SP.25.05 for a second reading and moved approval. Gilmore explained that the revision reorganizes existing language around three stages, initiation, Senate consideration, and incorporation, without substantively altering the current process. The revision also adds greater clarity regarding what documents each body should transmit at various stages. Gilmore noted a minor typographical error on line 144, in which "Senates" in "University Senates Conference" was not pluralized, and indicated it would be corrected as a minor amendment.

Faculty senator Weible (SIS) raised a concern that language in lines 189–193, stating that the Board of Trustees may adopt amendments over the objections of the senates, may inadvertently expand Board authority beyond what the current *Statutes* provide. Weible argued that in the current *Statutes* this provision applies only to Board initiated proposals and suggested that in the current ambiguities should be resolved in favor of stronger protections against external political influence. Gilmore acknowledged the concern and indicated the committee would be willing to revisit the language.

Faculty senator Varden (LAS) made a motion to return SP.25.05 to SP for further consideration. The motion was seconded, and a vote was taken.

By a show of hands and Poll Everywhere vote, the motion to return SP.25.05 to SP for further consideration was approved with 147 in favor, 8 opposed, and 12 abstentions.

e) SP.26.07, Proposed Revision to the *Constitution*, Article II, Section 1.b – Faculty Representation

On behalf of SP, Chair Gilmore presented SP.26.07 for a second reading, noting that this proposal originated from the Senate Committee on Elections and Credentials (EC). Gilmore

provided a summary and moved approval. The proposal would strike language in lines 14–15 that excludes individuals from the faculty electorate who are pursuing a degree from the University. Gilmore noted that a separate provision in Article 4 of the *Constitution* already prevents dual membership in electorates. As an amendment to the *Constitution*, the proposal would require Board of Trustees approval if passed. No discussion.

By a show of hands and Poll Everywhere vote, the motion to adopt SP.26.07 as presented was approved with 159 in favor, 2 opposed, and 4 abstentions.

f) SP.26.08, Revision to *Standing Rules 1 - Adjournment and 16 - Requesting to Speak at a Senate or Senate Committee Meeting*

On behalf of SP, Chair Gilmore presented and moved approval of SP.26.08. He noted that most of the changes are minor clarifications aimed primarily at external readership, people who might want to speak to the Senate or a Senate committee, but who do not normally correspond with the body. Rules 1 and 16 address the conduct of Senate meetings and the process by which a request to speak may be submitted, including clarifying where a request resides and what to do with it. No discussion.

By a show of hands and Poll Everywhere vote, the motion to adopt SP.26.08 as presented was approved with 166 in favor, 1 opposed, and 3 abstentions.

g) SP.26.12, Revision to the *Bylaws, Part F.7 - Remote Participation in Senate and Senate Committee Meetings*

On behalf of SP, Chair Gilmore presented and moved approval of SP.26.12. He noted that under the Illinois Open Meetings Act (OMA), the Senate may conduct remote participation so long as it maintains clear rules aligned with the Act. The revision restructures the existing language for clarity, and incorporates two new items: the addition of active military duty as an accepted category for remote participation, effective January 2026, included at line 40; and a shortened notification window, set by the Clerk of the Senate at a minimum of four hours prior to the scheduled start of a meeting, reflected at line 47. No discussion.

By a show of hands and Poll Everywhere vote, the motion to adopt SP.26.12 as presented was approved with 170 in favor, 0 opposed, and 1 abstention.

h) RS.24.01, Resolution on the Allocation of Resources to Address Impacts of Collective Bargaining Agreements

On behalf of RS.24.01 co-sponsors, Resolution Representative and faculty senator Stirek (FAA) introduced and moved approval of RS.24.01. The motion was seconded and discussion followed.

Stirek explained that the resolution calls on the Senate Committee on the Budget (BG) to work with the Office of the Provost to create and monitor policies ensuring that funds are allocated to address the budgetary impacts of collective bargaining agreements (CBAs). She noted that under the current model, CBA costs are absorbed by individual colleges and units even though the university, not those units, is the negotiating party, creating a lack of predictability for units.

Peter Silhan, Chair of Senate Committee on the Budget (BG), presented BG's response, concluding that the resolution was unnecessary given existing information sharing mechanisms within the current budget model and unworkable given the idiosyncratic nature of CBA impacts across units. BG raised concerns about vague language, scope creep, timing relative to the fiscal year, and the use of the words "assist" and "ensure," which BG felt implied administrative responsibilities beyond its advisory and oversight role.

Several senators spoke in favor of the resolution, arguing that its directive is fully consistent with BG's existing charge to monitor the allocation of campus resources and the implications of budget decisions, and that the resolution uses language drawn directly from the committee's own bylaws. Supporters also cited specific instances of building maintenance deficiencies potentially connected to CBA budgetary impacts and expressed support for elevating labor issues and strengthening the Senate's role in matters affecting University workers. One senator questioned whether the resolution might inadvertently constrain future collective bargaining by establishing a budget framework administrators could reference as a cap in negotiations.

A motion was made to discharge BG. The motion was seconded but ruled out of order as a main motion and referred to the New Business section of the agenda.

Senator Holt (ACES) moved to amend the resolution by replacing "assist" with "advise" and adjusting related language so that BG would advise the University administration on the creation and monitoring of relevant policies.

By a show of hands and Poll Everywhere vote, the motion to amend RS.24.01 was approved with 137 in favor, 6 opposed, and 19 abstentions.

A motion to close debate on the amended RS.24.01 was made and seconded.

By a show of hands and Poll Everywhere vote, the motion to close debate was approved with 155 in favor, 1 opposed, and 7 abstentions.

By a show of hands and Poll Everywhere vote, the motion to adopt RS.24.01 as amended was approved with 120 in favor, 20 opposed, and 22 abstentions.

7. PUBLIC COMMENT

No requests received.

8. CHANCELLOR'S REMARKS

John Coleman, Provost and Executive Vice Chancellor for Academic Affairs, shared the following remarks on behalf of Chancellor Charles L. Isbell, Jr. Provost Coleman began with highlighting two recent University recognitions. The 2026 Carnegie Community Engagement Classification, awarded for excellence in public engagement and the University's demonstrated commitment to collaboration across teaching, research, service, and operations. The other recognition was the 2026 Senator Paul Simon Award for Campus Internationalization from NAFSA (National Association of Foreign Student Advisers), recognizing Illinois as one of five national recipients for excellence in preparing students for a globalized society.

Provost Coleman then addressed the ongoing conflict in the Middle East, noting that the University's priority is the safety and academic continuity of its students, faculty, and staff. He reported that the travel registry was reviewed, and no affiliated travelers were found in immediately impacted areas. University related travel to the Middle East is currently under review through April 19, 2026. Illinois International reached out to 388 students, faculty, and staff from countries listed in a recent U.S. State Department evacuation advisory to offer support and information about available University resources.

Coleman provided an update on the "Illinois Leads" strategic planning process, co-chaired with Eva Pomerantz. A campuswide survey has been launched to gather anonymous community input, and a series of focus groups has begun. He encouraged all units, departments, and student organizations to conduct their own internal sessions and submit feedback to the steering committee.

Coleman noted that regular admission decisions had been released and thanking faculty and staff for their engagement with prospective students. Coleman closed with reflections

on the University's civic role and responsibility, emphasizing that the University of Illinois is an integral part of the civic fabric of society. He noted that this obligation extends beyond the core academic mission of education, research, and engagement to include preparing students to participate constructively in civic and social life, and to serving as a forum for curiosity, competing perspectives, and open debate. He expressed his view that no institution is better positioned, or more obligated, than a premier public research university to fulfill that role, particularly during a period of significant national and global change.

9. QUESTIONS FROM SENATORS

Faculty senator Somerville (LAS) inquired about the status of the task force on Title VI procedures. Coleman indicated the committee is nearly finished with its report. Somerville also raised a follow-up question regarding the University's procedures for ensuring that student disciplinary policies are applied fairly across the student population and among registered student organizations (RSOs). Coleman noted that a Senate committee [Senate Committee on Student Discipline (SD)] addresses student disciplinary matters and that such issues are more broadly centered in the Office of Student Affairs. He offered to follow up with additional information.

Student senator Graves (LAS) raised concerns about recent posts on social media by the Illini Republicans that she characterized as racially discriminatory and harmful to the sense of belonging among students of color on campus. Coleman encouraged those with concerns to file complaints with the Title VI. He also acknowledged that as a community engaged in open and often contested debate, it is appropriate to hold one another accountable when remarks cross the line.

Faculty senator Varden (LAS) asked whether the administration had communicated with department chairs and heads, in addition to directly affected students, to encourage them to reach out to faculty and students affected by the conflict in the Middle East. Coleman responded that he typically distributes such messages to the deans and encourages them to share the information further within their colleges as appropriate, with additional distribution through chief communications officers in the colleges and other units.
