



Proposal to the Senate Educational Policy Committee

PROPOSAL TITLE: Reorganize and revise the undergraduate curriculum in Journalism and re-designate the Bachelor of Science in Journalism (BSJ) degree with majors in Broadcast Journalism and News Editorial as the Bachelor of Science (BS) degree with a major in Journalism.

BRIEF DESCRIPTION: We propose to reorganize and revise the existing undergraduate curriculum in journalism. Students currently choose between two majors: News Editorial or Broadcast Journalism. This proposal seeks to create a single major.

The current Bachelor of Science in Journalism (BSJ) degree will be re-designated as the Bachelor of Science (BS) degree.

JUSTIFICATION:

This reorganization and revision will facilitate flexibility for the Journalism program in the future and give the program a name unencumbered by outdated media labels and concepts. Such changes already have been enacted at many peer programs. Programs at Northwestern University, the University of North Carolina at Chapel Hill, the University of Wisconsin, Ohio University and Indiana University, for example, now have a common Journalism major. The change will simplify degree certification, and better reflect modern professional practice in which distinctions based on the particular name of a journalism medium are dissolving.

The change will give journalism students greater latitude in course planning. The two majors are now largely the same, differing primarily by a set of three courses. With the change, students will no longer face some course restrictions required under the current majors. This will give students greater course flexibility and better prepare them for a rapidly changing journalism profession.

Courses in the Journalism curriculum have been renumbered to better reflect the four-year status of the College of Media. The new numbers give students a clearer and more systematic approach to building the core and advanced competencies that are demanded by the journalism profession. The proposal for the new curriculum in Journalism reflects the new course numbers. This proposal also makes clear how the new course numbers replace the old courses.

One change in this new curriculum would require all Journalism majors to complete 6 hours of Economics courses (generally Econ 102 and 103) – currently a requirement of the News Editorial major only. The Economics Department believes that it will be able to accommodate the small additional demand for course seats within their existing course structures without the need for additional resources (see attached letter.) The current differences in supporting work outside the major are reconciled by a compromise between the two existing sets of requirements.

Current News Editorial and Broadcast Journalism will be allowed to choose the new major or continue on to graduation under the “old” distinctions. Advisers in the College of Media Student Services Center will closely monitor the progress of all journalism students toward their degrees to ensure that students successfully satisfy either “old” or “new” requirements.

The College of Media has discussed with the Econ Department a proposal of combining the News Editorial major and the Broadcast Journalism major and would like to require Econ 102 and 103 for this new combined major. The College of Media estimates that somewhere near 25 additional students will enroll in the courses. This impact is acceptable to the Department of Economics and we anticipate being able to handle this additional demand on a regular basis.
