

## **Proposal to the Senate Educational Policy Committee**

**PROPOSAL TITLE:** Elimination of the Horticulture major in the Department of Crop Sciences in the College of Agricultural, Consumer and Environmental Sciences.

**BRIEF DESCRIPTION:** The Department of Crop Sciences proposes the elimination of the Horticulture major in the Department of Crop Sciences in the College of Agricultural, Consumer and Environmental Sciences.

JUSTIFICATION: The Department of Crop Sciences proposes to eliminate Horticulture as a major and incorporate the horticulture students into the Crop Sciences major. Several years ago the horticulture program merged into the Department of Crop Sciences. The current Horticulture major has two concentrations with 23 (77%) students in Specialty Crops and 7 (23%) students in Sustainable Landscapes. The demand for students in the ornamental horticulture industry has been declining. Also, due to the loss of some faculty and Teaching Associate positions in the department, strength in the ornamental horticulture area has declined making it difficult to offer the classes needed in that area. Thus, the proposed change is in response to several factors including loss of capability to deliver classes and lack of demand from students (low enrollments in classes). Decline in students majoring in ornamental horticulture is also occurring at other institutions. Current students will be allowed to complete their current programs of study.

The proposed changes are supported by the faculty in the department, including most of the faculty in the horticulture area. In the faculty vote, 91% (29/32) voted in favor of eliminating the Horticulture major.

Additional staff and dollars needed

The proposed revisions do not create a need for additional resources; however, in order for the department to incorporate the students into the Crop Sciences program there is a need to commit to current staffing levels. It is understood within the department that funds will be required to

continue to pay existing Academic Professionals who are involved in providing instruction in several horticulture courses both new and already established.

Internal reallocations (e.g., change in class size, teaching loads, student-faculty ratio, etc.)

Our intent is to maintain the HORT rubric in the Crop Sciences Department, and continue to offer classes under this rubric with the current faculty and academic professionals teaching them. In this past academic year, several horticulture courses have been discontinued due to low enrollment, and new courses are being developed that are more aligned with current interests in horticulture. The intent is to build the enrollment in these courses that will be more beneficial to students going into careers in emerging specialties in horticulture. There is capacity available, and the faculty members in the horticulture area are willing to develop revised classes and teach classes with larger enrollments. See related proposal to create a concentration in Horticultural Food Systems within the major in Crop Sciences.

Effect on course enrollment in other units and explanations of discussions with representatives of those departments

No changes in class enrollments outside of ACES are anticipated as a result of this change. It is anticipated that students who would have selected a major in Horticulture will now select a major in Crop Sciences, and take similar required courses outside the Crop Sciences Department.

**DESIRED EFFECTIVE DATE:** We would like to implement these revisions as soon as possible, but we understand that they must be approved at a number of levels. Ideally, we would like to have the effective date be Fall semester of 2015.
