BRIEF DESCRIPTION

On October 23, 2007 the line-weight faculty of the Latina/Latino Studies Program voted unanimously (7 yes votes; 0 no votes) to reorganize into the Department of Latina/Latino Studies. The reorganization reflects our operation as a tenure-granting autonomous academic unit.

JUSTIFICATION

The Latina/Latino Studies Program (LLSP) began in 1995 as an interdisciplinary unit in the College of Liberal Arts and Sciences. Within the CIC universities, six universities have a Latina/o or Chicana/o Studies Program and only Purdue, Northwestern, and University of Illinois-Chicago offers a Latina/o Studies major. There are currently no departments of Latina/o Studies. Presently, UIUC has the largest and most established curricular program among the CIC schools. For the past six years, LLSP has been involved in faculty recruitment and today holds 9 line-weight appointments across different colleges and departments. In 2004, then-Provost Richard Herman granted LLSP "Enhanced Rights" to hire, tenure and promote faculty. In 2008 the Program was involved in its first case for the tenure and promotion of a faculty member. Granting the Program departmental status will affirm the unit's status as an academic unit and establish UIUC as an intellectual leader in the area of ethnic and race studies in the Midwest.

Course offerings and degree programs: In 1996, LLSP established its Undergraduate Minor and in 2008, LLSP established a Graduate Minor. The proposal for an Undergraduate Major has been submitted and approved by the College of LAS, UIUC Senate and is under review at the Board of Trustees. LLSP currently offers an average of 16 undergraduate courses and 8 graduate courses per semester. (See Appendix A for list of course offerings). During the 2008-2009 academic year, LLSP offered 1980

instructional units on campus with FTE unit funds. We expect that number to increase substantially in the coming years.

<u>Faculty and Staff</u>: The unit currently consists of 9 faculty with budgeted appointments totaling 5.74 FTE (3 at 100%, 1 at 75%, 2 at 50 %, 1 at 49%, 2 at 25%). In addition, the Program is staffed with an Associate Chair responsible for academic programming, curriculum development and advising (see Appendix B for list of instructional faculty); one Visiting Assistant Professor; two Chancellor's Post-Doctoral Fellows, each of whom teaches one course during their 12-month appointments; two non-recurring instructional staff members; three teaching assistants; one graduate outreach coordinator; one undergraduate outreach coordinator; and one Office Manager. LLSP is in the process of formalizing the zero-percent appointments for the remaining 15 affiliate faculty who regularly teach cross-listed courses for the Program.

<u>Publications and Events</u>: The unit produces an annual report, newsletter, brown bag lecture series, endowed lecture series, invited lectures and an international biennial graduate student conference.

Governance: LLSP is a self-governing unit that administers its own budget, evaluates faculty annually and recommends faculty for tenure and promotion. The unit is governed by existing bylaws and in accordance with the University Statutes the unit executive officer functions as a department "chair" (See Appendix C for the LLS Department Bylaws). The Program is under the leadership of Isabel Molina, Ph.D. Communications. Alicia Rodriguez, the Associate Director of undergraduate advising oversees the teaching assistants and the development of the undergraduate and graduate curriculum. The Office Manager oversees the student-worker staff, facilities and the budget.

BUDGETARY AND STAFF IMPLICATIONS

The budgetary consequences are minimal. Letterhead and other print materials will need to be updated. The costs for updating materials will be absorbed by the Program. The reorganization will not require additional staff, funding or internal reallocations. There will be no effect on course enrollments in courses offered in conjunction with other departments. The reorganization will not impact library, computer use, laboratory use or other equipment.

Minutes from the Public Hearing Reorganization of the Gender and Women's Studies Program to the Department of Gender and Women's Studies

And

Reorganization of the Latina/Latino Studies Program to The Department of Latina/Latino Studies

December 9, 2009 2:00-3:00 pm Lucy Ellis Lounge Foreign Languages Building

Professor Abbas Aminmansour, Chair of the Educational Policy Committee, welcomed everyone and asked that if anyone had comments to send them via email to aamin@uiuc.edu. The first speaker was Dean Ruth V. Watkins, who spoke on behalf of the College of Liberal Arts and Sciences (LAS). The College wholeheartedly supports the reorganization of Gender and Women's Studies (GWS) from a program to a department. The GWS program has been in existence for more than 20 years. Currently, GWS has 9.0 FTE faculty. Twelve of these faculty are tenured and six have GWS as their home unit. The GWS Program has offered an undergraduate minor since 1987, a graduate minor since 1993, and an undergraduate major since 2003. There are currently a total of 78 courses in GWS, 28 controlled by the unit. The unit functions as a department and should be called a department.

The second speaker was Professor Chantal Nadeau, Head of the Gender and Women's Studies Program. Please see the attached power point slides for the exact text of her talk. Professor Aminmansour asked if there were any questions, no one offered any comments.

Dean Watkins came back to the podium to give a brief overview of the Latina/Latino Studies Program. The unit (LLSP) began in 1995 as an interdisciplinary unit in the College of LAS. Within the CIC universities, six have a Latina/o or Chicana/o Studies Program, and only Purdue, northwestern, and University of Illinois-Chicago offer a Latina/o Studies major. There are currently no departments of Latina/o Studies. Presently, UIUC has the largest and most established curricular program among the CIC schools. For the past six years, LLSP has been involved in faculty recruitment and today holds 9 line-weight appointments across different colleges and departments. In 2004, then Provost Richard Herman granted LLSP "Enhanced Rights" to hire, tenure, and promote faculty. In 1996, LLSP established its undergraduate minor and in 2008, LLSP established a graduate minor. The proposal for an undergraduate major has been submitted and approved by the College of LAS and UIUC Senate and is under review by the Board of Trustees.

The next speaker was Professor Isabel Molina, Head of the Latina/o Studies Program. Please see the attached power point slides for the exact text of her talk.

The next speaker was Manuel Colon, Chapter President of Alpha Psi Lambda, who has requested in advance the right to address the hearing. He spoke of his organization's strong support for the proposal to reorganize LLSP into an academic department. His comments are appended to this document.

Professor Aminmansour asked if there were any questions or comments from the floor.
David Olsen spoke first. He is a student member of the Senate Educational Policy
Committee. He asked about why the Department wishes to be named "Women and Gender

Studies" when the unit bylaws do not mention women's studies specifically, although they do mention gender and sexualities studies in their mission statement portion of the bylaws. Professor Chantal asked that some of her unit faculty speak to the historical reasons for the name of the unit. Professor Siobhan Somerville stated that the original name of the unit was the Women's Studies Program, but that the unit voted to change its name to Gender and Women's Studies Program in 2003 to reflect a shift in the discipline from a single focus on women to a broader focus on the issues of gender and sexualities, while preserving acknowledgment that a continued study of women was central to the discipline. The new name also arose in recognition of intersectional research involving theories and methodologies of feminist theory, queer theory, race studies, etc. Professor Nadeau then added that she had attended a recent meeting of department heads of units whose names varied from Women's Studies, Gender Studies, Gender and Women's Studies, Gender and Sexuality Studies, etc. and that those who retain "Women" as part of their title do so in recognition both of the historical contributions of women's and feminist studies to the development of the discipline as well as to their current methodological and epistemological focus of their current research interests.

Professor Lisa Nakamura, Director of the Asian American Studies Program, noted that several of her faculty have affiliate appointments with either Gender and Women's Studies or Latina/o Studies, and wanted to go on record about how well-run both units are.

Adele Lozano, Director of La Casa Cultural Latina, spoke of the importance of the Latina/o Studies Program to students and to the campus as a whole.

No other questions or comments were asked and the meeting was adjourned.
